## The Commonwealth of Massachusetts

In the Year Two Thousand and Nine

AN ACT CONCERNING THE AUTHORITY OF THE DEPARTMENT OF PUBLIC HEALTH TO OPERATE THE PUBLIC HEALTH HOSPITALS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:
