By Ms. Malia of Boston, a petition (accompanied by bill, House, No. 2402) of Elizabeth A. Malia and others for legislation to establish a training program for the treatment of certain opioid use and alcohol use disorders. Mental Health, Substance Use and Recovery.

**The Commonwealth of Massachusetts**

**In the One Hundred and Ninetieth General Court  
(2017-2018)**

An Act to expand access to medication-assisted treatment providers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1: The Department of Public Health and the Massachusetts Board of  
2 Registration in Medicine shall develop or provide for, and make available for voluntary  
3 participation by any physician, a professional training module on the prescribing and  
4 administration of naltrexone, both pill and injectable form, for the treatment of opioid use  
5 disorders and alcohol use disorders. The training module shall include, but not be limited to  
6 guidelines and best practices for:

7 A. Assessment;

8 B. Care Coordination;

9 C. Treatment Plans, including counseling frequency and type;

10 D. Toxicology Screens;

11 E. Appropriate Length of Treatment; and

12 F. Relapse Prevention

13 The training module developed shall be accepted by the board as up to 2 continuing  
14 professional development credits.

15 SECTION 2: Notwithstanding any special or general law to the contrary, the Department  
16 of Public Health and the Bureau of Substance Abuse Services shall establish an extended release  
17 naltrexone training and technical assistance program for providers licensed or certified by the  
18 Department of Public Health. The Department shall prioritize training and ongoing technical  
19 assistance for providers serving cities and towns of the Commonwealth with greater than ten  
20 opioid related fatalities per ten thousand as documented in the study authorized by Chapter 55 of  
21 the Acts of 2015. The Department shall also evaluate and direct training to expand the number  
22 of providers serving individuals released from Department of Correction facilities and Houses of  
23 Correction. Provided further, that said training program shall include, but not be limited to the  
24 following criteria: patient eligibility, optimal selection criteria, placement matching, patient  
25 engagement, team coaching and coordination, withdrawal management and induction, dosing  
26 and administration, clinical evaluation and laboratory monitoring, side effect management, co-  
27 occurring disorders management, drug interactions, persistence management, managed care  
28 interactions, and termination of medication.

29 SECTION 3: The Department of Public Health shall submit a report to the house and  
30 senate committees on ways and means and the joint committee on mental health and substance  
31 abuse on the number of providers trained and any identified obstacles to expanding the number  
32 of providers trained in extended release naltrexone by January 1, 2018.
