An Act relative to the fairness of marine vessel reporting and fishermen exemptions.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 60B of the General Laws, as appearing in the 2014 Official  
2 Edition, is hereby amended in Section 1 by inserting the following in line 4:-

3 “Director”, the director of the division of law enforcement of the department of fisheries,  
4 wildlife and environmental law enforcement.

5 SECTION 2. Chapter 60B of the General Laws, as appearing in the 2014 official edition,  
6 is hereby amended in Section 2 (b) by striking in line 8 the word “August” and replacing it with  
7 the word “September”.

9 SECTION 3. Chapter 60B of the General Laws, as appearing in the 2014 official edition,  
10 is hereby amended in Section 2 (g) by adding at the end thereof in line 45 the following:

11 “No abatement under this section shall reduce any excise to less than 5 dollars; no  
12 abatement shall be granted in an amount less than 5 dollars and no refund shall be paid in an  
13 amount less than 5 dollars.”

14 SECTION 3. Chapter 60B of the General Laws, as appearing in the 2014 official edition,  
15 is hereby amended in Section 2 (h) in line 47 after the word “otherwise” the following:- “and the  
16 registration of such vessel is surrendered,”

17 SECTION 4. Chapter 60B of the General Laws, as appearing in the 2014 official edition,  
18 is hereby amended in Section 3 by striking the text in its entirety and replacing it with the  
19 following new section:-

20 “Section 3. The excise imposed by this chapter shall not apply to vessels described in  
21 section 8 of chapter 59 and in section 67 of chapter 63; to vessels owned by the commonwealth  
22 or any political subdivision thereof; to law enforcement vessels; to vessels under construction; to  
23 ferries; to boats, fishing gear and nets, with a value of 50 thousand dollars or less, owned and  
24 actually used by the owner in the prosecution of his business if engaged in commercial fishing  
25 and if no less than 50 per cent of his income is from commercial fishing; nor to other vessels  
26 with a value of 1 thousand dollars or less. Said exemptions shall not subject said vessels and their  
27 equipment to any other tax under chapter 59.”

28 SECTION 5. Chapter 60B of the General Laws, as appearing in the 2014 official edition,  
29 by inserting after Section 5 the following new section:-

30 Section 5A. No owner of a vessel shall be issued a registration decal or certificate of  
31 number, or renewal of such decal or certificate, under sections 2A and 3 of chapter 90B unless  
32 the owner has included with the application for such decal or certificate proof of payment of the  
33 full amount of the excise assessed for the prior fiscal year for any vessel for which the owner has  
34 a decal or certificate on July 1 of such year. Upon failure of the applicant to provide such proof  
35 of payment, or receipt of such other notice of non-payment made by the local tax collector that  
36 the director may determine, the director shall place the matter on record and not issue or renew a  
37 registration decal or certificate of number for any vessel owned by the person to whom the  
38 unpaid excise tax was assessed until after notice from the local tax collector that the matter has  
39 been disposed of in accordance with law. The provisions of section 2A of chapter 60A shall  
40 apply to any notifications of non-payment made by the local tax collector.

41 SECTION 6. Chapter 60B of the General Laws, as appearing in the 2014 official edition,  
42 by inserting after Section 6 by striking the words in their entirety and replacing it with the  
43 following new section:-

44 Section 6. The director shall annually, on or before October 1, transmit to the board of  
45 assessors of each city and town a list of all ships or vessels which were documented or registered  
46 on the immediately preceding July 1. The list shall include for each vessel, the name and  
47 residential address of the registered owner, if an individual, or name and principal place of  
48 business, if a corporation, partnership or other entity, the city or town in which the vessel is  
49 habitually moored or docked, the name of the manufacturer, the year of manufacture as  
50 designated by the manufacturer, the model type, the length, the horsepower of the engine or  
51 motor used to propel the vessel, the document number or certificate of number and the value as

52 determined by the commissioner. The director may require from the owner such information as  
53 may be necessary for purposes of this chapter.

54 SECTION 7. Chapter 90B of the General Laws, as appearing in the 2014 Official  
55 Edition, is hereby amended by inserting after section 2 in the following section:-

56 Section 2A. The owner of a vessel, which has a valid marine document issued by the  
57 Bureau of Customs of the United States or any federal agency successor thereto and is  
58 homeported in the commonwealth or maintained in commonwealth waters by a resident of the  
59 commonwealth, shall apply to the director on a form prescribed him for a registration decal or  
60 renewal thereof. The application shall be signed by the owner of the vessel and submitted to the  
61 director together with a fee, as determined annually by the commissioner of administration under  
62 the provision of section 3B of chapter 7.

63 SECTION 8. Section 3 of Chapter 90B of the General Laws, as appearing in the 2014  
64 Official Edition, is hereby amended by adding the following subsection:-

65 (l) Registration information for such motorboats shall be maintained by the department  
66 and transmitted to the board of assessors of each city and town for the purposes of assessing the  
67 excise imposed by chapter 60B.

68 SECTION 9. This act shall apply to excises assessed for any fiscal year beginning on or  
69 after July 1, 2019.
