AN ACT TO CERTIFY COMMUNITY HEALTH WORKERS IN MASSACHUSETTS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Pursuant to Section 110 of Chapter 58 of the Acts of 2006, which mandated recommendations for a
2 community health worker certification program, Chapter 13 of the Massachusetts General Laws is hereby
3 amended by inserting after Section 97 the following:

4 Section 98: There shall be a board of certification of community health workers hereinafter called the
5 board. The board shall be included in the Division of Health Professions Licensure at the Department of
6 Public Health. The board shall regulate the training and certification of community health workers and
7 shall have the following duties:

- 8 (a) develop and administer a certification program for community health workers, including
9 training and continuing education requirements, adopting a system to document and
10 recognize prior learning, mastery of core competencies, and including grandfathering
11 guidelines for certification of community health workers practicing in Massachusetts at
12 the time of passage of this section;
- 13 (b) develop and administer certification programs for individuals, community health worker
14 trainers and organizations that train community health workers, including guidelines
15 defining training curricula based on core competencies and guidelines for additional
16 training in specialized areas of practice;
- 17 (c) develop, administer, and enforce provisions for granting and revoking certification for
18 the practice of community health work and the training of community health workers;
- 19 (d) conduct public hearings and keep records and minutes as are necessary to carry out its
20 duties. The board shall provide a 30 day public notice of the times and places of all
21 hearings authorized under this section, in a manner it may determine.

22 The board shall consist of 11 members to be appointed by the governor. One member shall be the
23 commissioner of the department of public health, or his/her designee, who shall chair the board.
24 Additional members shall be appointed to ensure representation of all six geographic regions of the
25 executive office of health and human services and shall include no fewer than four community health
26 workers selected from recommendations offered by the Massachusetts Association of Community Health
27 Workers; one representative of a community health worker training organization; one representative of
28 the Massachusetts Public Health Association; one representative of the Massachusetts Association of

29 Health Plans; one representative of the Massachusetts League of Community Health Centers; one
30 community-based CHW employer representative and one consumer representative familiar with
31 community health worker services.

32 Of the first appointments three shall serve one year, three shall serve two years and four shall three years.
33 Each appointed member of the board thereafter shall serve terms of 3 years. No member shall be
34 appointed to more than 2 consecutive full terms. A former member shall again be eligible for appointment
35 after a lapse of one or more years.

36 The board shall, at its first meeting, and annually thereafter, elect from among its members a vice-
37 chairperson, and a secretary. Such officers shall serve until their successors are elected. The board shall
38 meet at least quarterly or more often upon the call of the chairman at such times and places as the
39 chairperson shall designate.

40 Board members shall serve without compensation but be reimbursed for necessary expenses incurred in
41 the discharge of their official duties.

42 The board shall be supported, subject to appropriation, with a director, administrative assistant, and such
43 other professional staff and operating expenses as are required to discharge its responsibilities under this
44 section.
