Kaufman and others for an investigation by a special commission (including members of the General Court) to develop a proposal for the establishment of a program of civics education and public service for the youth of the Commonwealth. Education.

# The Commonwealth of Massachusetts

In the One Hundred and Ninetieth General Court (2017-2018)

Resolve to promote better citizenship, civics education and civic engagement.

1 Resolved, That there shall be a commission to develop a proposal for the establishment of 2 a program of civics education and public service for the youth of Massachusetts. The 3 commission shall consist of the following members: 4 members of the senate, 1 of whom shall 4 be the senate president or the senate president's designee, 1 of whom shall be the senate chair of 5 higher education or the chair's designee, 1 of whom shall be the senate chair of education or the 6 chair's designee, and 1 of whom shall be appointed by the minority leader; 4 members of the 7 house of representatives, 1 of whom shall be the speaker of the house or the speaker's designee, 8 1 of whom shall be the house chair of higher education or the chair's designee, 1 of whom shall 9 be the house chair of education or the chair's designee, and 1 of whom shall be appointed by the 10 minority leader; the secretary of education or the secretary's designee; the commissioner or 11 education or his designee, the commissioner of higher education or his designee, and 4 members 12 appointed by the governor who shall have demonstrated experience in and commitment to public service and civic education. 13

14 The commission shall investigate and study communities, states or nations that have 15 public service requirements for youth, and organizations that promote service in the United 16 States and the Commonwealth, such as but not limited to AmeriCorps and the Peace Corps. The 17 study shall consider these questions: when and how in their schooling shall students be exposed 18 to civics education and expected to engage in public service; how and what agency shall 19 administer the program; how will the program be funded; how will quality of programming be 20 maintained; what incentives or rewards should be in place for participation and success; if the 21 service participation should be mandatory; and other questions that the commission members 22 deem fitting.

The commission shall report its findings, including any proposed legislation, to the chairs of the senate and house committees on ways and means, the senate and house clerks, the joint committee on education, the joint committee on higher education, the executive office of education, and the office of the governor no later than January 1, 2019.
