By Mr. Golden of Lowell, a petition (accompanied by bill, House, No. 2815) of Thomas A. Golden, Jr. for legislation to create a health policy commission. State Administration and Regulatory Oversight.

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act relative to health policy commission membership.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 6D of the General Laws is hereby amended by striking section (2) and inserting  
2 in its place thereof, the following new section:-

3 Section 2. (a) There shall be established within the executive office for administration  
4 and finance, but not under its control, a state agency known as the health policy commission. The  
5 commission shall be an independent public entity not subject to the supervision and control of  
6 any other executive office, department, commission, board, bureau, agency or political  
7 subdivision of the commonwealth.

8 (b) There shall be a board, with duties and powers established by this chapter, which shall  
9 govern the commission. The board shall consist of 11 members: 1 of whom shall be the secretary  
10 for administration and finance, ex officio; 1 of whom shall be the secretary of health and human  
11 services, ex-officio; and 3 of whom shall be shall be appointed by the governor, 1 of whom shall  
12 serve as chairperson; 3 of whom shall be appointed by the attorney general; and three members  
13 shall be appointed by the auditor; provided, however, that said designees shall not be employees  
14 of the commission or any division thereof. All appointments after the initial term of appointment  
15 shall serve a term of 5 years, but a person appointed to fill a vacancy shall serve only for the  
16 unexpired term. An appointed member of the board shall be eligible for reappointment; however,  
17 no appointed member shall hold full or part-time employment in the executive branch of state  
18 government. The board shall annually elect 1 of its members to serve as vice-chairperson. Each  
19 member of the board serving ex officio may appoint a designee under section 6A of chapter 30.

20 The person appointed by the governor to serve as chairperson shall have demonstrated  
21 expertise in health care delivery, health care management at a senior level or health care finance  
22 and administration, including payment methodologies. The initial appointment of the chairperson  
23 shall be for a term of 3 years; provided, however, that subsequent appointments shall be for a  
24 term of 5 years. The second person appointed by the governor, shall have demonstrated expertise  
25 in health plan administration and finance and shall be initially appointed for a term of 4 years.  
26 The third person appointed by the governor, shall be a primary care physician and shall be  
27 initially appointed for a term of 5 years. Of those persons appointed by the attorney general,  
28 1 shall have demonstrated expertise in health care consumer advocacy and shall be initially  
29 appointed for a term of 2 years; 1 shall be a health economist and shall be initially appointed for  
30 a term of 3 years; and 1 shall have expertise in behavioral health, substance use disorder, mental  
31 health services and mental health reimbursement systems and shall be initially appointed for a  
32 term of 1 year. Of those persons appointed by the auditor, 1 shall have demonstrated expertise in  
33 representing the health care workforce as a leader in a labor organization and shall be initially  
34 appointed for a term of 4 years; 1 shall have demonstrated expertise as a purchaser of health  
35 insurance representing business management or health benefits administration and shall be  
36 initially appointed for a term of 3 years; and 1 shall have demonstrated expertise in the  
37 development and utilization of innovative medical technologies and treatments for patient care  
38 and shall be initially appointed for a term of 2 years.

39 (c) Six members of the board shall constitute a quorum, and the affirmative vote of 6  
40 members of the board shall be necessary and sufficient for any action taken by the board. No  
41 vacancy in the membership of the board shall impair the right of a quorum to exercise all the  
42 rights and duties of the commission. Members shall serve without pay, but shall be reimbursed  
43 for actual expenses necessarily incurred in the performance of their duties. Each member shall  
44 make full disclosure, under subsection (d), of his financial interest, if any, in matters before the  
45 board by notifying the state ethics commission, in writing, and shall abstain from voting on any  
46 matter before the board in which he has a financial interest, unless otherwise permissible under  
47 chapter 268A.

48 (d) Chapters 268A and 268B shall apply to all ex-officio members or their designees and  
49 employees of the commission. Said chapters 268A and 268B shall apply to all other members of  
50 the commission, except that the commission may purchase from, sell to, borrow from, loan to,  
51 contract with or otherwise deal with any person in which any member of the commission is in  
52 any way interested or involved; provided, however, that such interest or involvement is disclosed  
53 in advance to the members of the board and recorded in the minutes of the board; and provided,  
54 further, that no member having such an interest or involvement may participate in any decision  
55 of the board relating to such person. Employment by the commonwealth or service in any agency  
56 thereof shall not be deemed to be such an interest or involvement.

57 (e) Any action of the commission may take effect immediately and need not be published  
58 or posted unless otherwise provided by law. Meetings of the commission shall be subject to

59 sections 18 to 25, inclusive, of chapter 30A; provided however that said sections shall not apply  
60 to any meeting of members of the commission serving ex officio in the exercise of their duties as  
61 officers of the commonwealth if no matters relating to the official business of the commission  
62 are discussed and decided at the meeting. The commission shall be subject to all other provisions  
63 of said chapter 30A, and records pertaining to the administration of the commission shall be  
64 subject to section 42 of chapter 30 and section 10 of chapter 66. All moneys of the commission  
65 shall be considered to be public funds for purposes of chapter 12A. Except as otherwise provided  
66 in this section, the operations of the commission shall be subject to chapter 268A and chapter  
67 268B.

68 The commission shall not be required to obtain the approval of any other officer or  
69 employee of any executive agency in connection with the collection or analysis of any  
70 information; nor shall the commission be required, prior to publication, to obtain the approval of  
71 any other officer or employee of any executive agency with respect to the substance of any  
72 reports which the commission has prepared under this chapter.

73 (f) The board shall appoint an executive director by a majority vote. The executive  
74 director shall supervise the administrative affairs and general management and operations of the  
75 commission and also serve as secretary of the commission, ex officio. The executive director  
76 shall receive a salary commensurate with the duties of the office. The executive director may  
77 appoint other officers and employees of the commission necessary to the functioning of the  
78 commission.

79 The executive director shall not be required to obtain the approval of any other executive  
80 agency in connection with appointment of employees. Sections 9A, 45, 46 and 46C of chapter  
81 30, chapter 31 and chapter 150E shall not apply to the executive director of the commission.  
82 Sections 45, 46 and 46C of chapter 30 shall not apply to any employee of the commission. The  
83 executive director may establish personnel regulations for the officers and employees of the  
84 commission.

85 The executive director shall file an annual personnel report not later than the first  
86 Wednesday in February with the senate and house committees on ways and means containing the  
87 job classifications, duties and salary of each officer and employee within the center together with  
88 personnel regulations applicable to said officers and employees. The executive director shall file  
89 amendments to such report with the senate and house committees on ways and means whenever  
90 any changes become effective.

91 The executive director shall, with the approval of the board:

92 (i) plan, direct, coordinate and execute administrative functions in conformity with the  
93 policies and directives of the board;

94 (ii) employ professional and clerical staff as necessary;

95 (iii) report to the board on all operations under their control and supervision;

96 (iv) prepare an annual budget and manage the administrative expenses of the  
97 commission; and

98 (v) undertake any other activities necessary to implement the powers and duties under  
99 this chapter.

100 The board may approve the use of funds from the Healthcare Payment Reform Fund to  
101 support the annual budget of the commission, in addition to funds from any other source and any  
102 funds appropriated therefore by the general court. The commission shall not be required to obtain  
103 the approval of any other executive agency in connection with the development and  
104 administration of its annual budget.

105 (g) Chapter 268A shall apply to all board members, except that the commission may  
106 purchase from, sell to, borrow from, contract with or otherwise deal with any organization in  
107 which any board member is in anyway interested or involved; provided, however, that such  
108 interest or involvement shall be disclosed in advance to the board and recorded in the minutes of  
109 the proceedings of the board; and provided further, that no member shall be deemed to have  
110 violated section 4 of said chapter 268A because of such member's receipt of such member's  
111 usual and regular compensation from such member's employer during the time in which the  
112 member participates in the activities of the board.

113 (h) The executive director shall appoint and may remove such agents and subordinate  
114 officers as the executive director may consider necessary and may establish such subdivisions  
115 within the commission as the executive director considers appropriate to fulfill the purposes  
116 under this chapter,.

117 The commission shall adopt and amend rules and regulations, under chapter 30A, for the  
118 administration of its duties and powers and to effectuate this chapter.
