Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- Section 1. Section 1A of chapter 15D of the General Laws is hereby amended in the
- 2 definition of "Group care facility" by adding in the second sentence after the words "children
- 3 with special needs" the following: ", including children with special needs under the age of 22.
