An Act reducing CPA recording fees for affordable housing.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 8a of chapter 44B of the General Laws, as so appearing, is hereby  
2 amended by inserting the following after the words “Chapter 188” in line xx: or to the filing of  
3 any subordinate mortgage extended by any public agency or quasi-public agency, including but  
4 not limited to a Commonwealth municipality or the Massachusetts Housing Partnership.

5           SECTION 2. Section 8b of chapter 44B of the General Laws, as so appearing, is hereby  
6 amended by inserting the following after the words “Chapter 188” in line xx: or to the filing of  
7 any subordinate mortgage extended by any public agency or quasi-public agency, including but  
8 not limited to a Commonwealth municipality or the Massachusetts Housing Partnership.
