Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Subsection (f) of section 139 of chapter 164 of the General Laws, as
- 2 appearing in the 2012 Official Edition, is hereby amended by striking out, in line 68, the figure
- 3 "4", as inserted by section 5 of chapter 251 of the acts of 2014, and inserting in place thereof the
- 4 following figure: 5.
- 5 SECTION 2. Said subsection (f) of section 139 of chapter 164, as so appearing, is hereby
- 6 further amended by striking out, in line 70, the figure "5", as inserted by section 6 of chapter 251
- 7 of the acts of 2014, and inserting in place thereof the following figure:- 7.
- 8 SECTION 3. Subsection (c) of section 7 of chapter 251 of the acts of 2014, as so
- 9 appearing, is hereby amended by striking out, in line 4, the date "March 31, 2015" and inserting
- 10 in place thereof the following: "June 1, 2015".
