By Mr. Winslow of Norfolk and Senator Ross, a joint petition (accompanied by bill, House, No. 307) of Daniel B. Winslow and Richard J. Ross (by vote of the town) relative to authorizing the town of Norfolk to grant an additional alcoholic beverages license to Sarthi Convenience, Inc., d/b/a/ Norfolk Food Mart. Consumer Protection and Professional Licensure. [Local Approval Received.]

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act authorizing the town of Norfolk to grant an additional alcoholic beverages license.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Notwithstanding section 17 of chapter 138 of the General Laws, the  
2 licensing authority of the town of Norfolk may grant an additional license for the sale of all  
3 alcoholic beverages not to be drunk on the premises under section 15 of said chapter 138 to  
4 Sarthi Convenience, Inc., d/b/a/ Norfolk Food Mart, located at 10 Rockwood Road, Norfolk,  
5 MA. The license shall be subject to all of said chapter 138 except said section 17. The applicant  
6 holds a Wine and Malt License which shall be surrendered upon licensing authority approval of  
7 the Package Store license.

9 SECTION 2. The licensing authority shall not approve the transfer of the license to any other  
10 location. The license may be reissued by the licensing authority to a new applicant at the same  
11 location if the applicant files with the licensing authority a letter from the department of revenue  
12 indicating that the license is in good standing with the department and that all applicable taxes  
13 have been paid.

15 SECTION 3. If the license granted under this section is cancelled, revoked or no longer in use,  
16 it shall be returned physically, with all of the legal rights, privileges and restrictions pertaining  
17 thereto, to the licensing authority which may then grant the license to a new applicant; or take  
18 any other action relative thereto.
