Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 1 of chapter 90 of the General Laws, as appearing in the 2008 1 2 Official Edition, is hereby amended by inserting after the definition of "Fullmount" the 3 following new definition:-4 "Functionally classified", shall refer to how a roadway is classified by the Federal Highway 5 Administration's functional classification system guidelines. 6 □ SECTION 2. Section 17 of said chapter 90, as so appearing, is hereby amended by striking 7 out, in line 13, the words "or (4)" and inserting in place thereof the following:- \Box (4) on a functionally classified local road at a rate of speed exceeding 25 miles per hour for a 9 distance of one-eighth of a mile, or (5). 10 □ SECTION 3. Chapter 85 of the General Laws, as appearing in the 2008 Official Edition, is 11 hereby amended by inserting after section 21A the following section:-12 Section 21B. Notwithstanding any general or special law to the contrary, a city or town may 13 establish, on ways within their control, one or more, senior citizen safety zones, which may be an 14 area adjacent to a facility, publicly or privately owned and used as senior citizen housing, a

- 15 hospital, nursing home or assisted living facility; a community center where senior activities are
- 16 conducted on a regular basis, or a congregate elderly residential facility.
- 17 □ A senior citizen safety zone may be established by a city council, the transportation
- 18 commission of the City of Boston, the board of selectmen, traffic commission, or traffic director,
- in the manner set forth by municipal charter or other local law, in the manner set forth by
- municipal charter or other local law, for the adoption of traffic rules, regulations, ordinances, or
- bylaws. The locally-designated body charged with regulating traffic may take necessary action to
- 22 reduce vehicular speed by reducing speed limits to not less than 20 miles per hour or such lower

- 23 speed limit as is set for school zones and by installing signals or appropriate signs and restriping
- 24 roadways, and may adopt and amend rules and regulations to carry out this section.
- 25 The city or town shall notify the state traffic engineer upon the establishment of a senior citizen
- 26 safety zone, and shall notify the state traffic engineer of any reduction of speed on a functionally
- 27 classified local roadway.
- 28 This section shall not apply to any state highway, numbered route or functionally-classified

- 31 Edition, is hereby amended by inserting after the word "hour", in line 15, the following words:-
- 32 \Box , or (5) within a senior citizen safety zone which may be established by a city or town as
- provided in section 21B of chapter 85 at a rate of speed exceeding 20 miles per hour or such
- 34 lower speed limit as is set for school zones.
- 35 SECTION 5. Section 2 of chapter 85 of the general laws, as appearing in the 2008 official
- 36 edition, is hereby amended by inserting after the phrase "schools zones," in line 35, the phrase
- 37 "senior safety zones."
- 38 □ SECTION 6. Chapter 85 of the General Laws, as appearing in the 2008 Official Edition, is
- 39 hereby amended by inserting after section 21B the following section:-
- 40 □ Section 21C. Notwithstanding any general or special law to the contrary, a city or town may
- 41 establish, on ways within their control, one or more, recreational safety zones, which may be an
- 42 area adjacent to a park, playground, athletic field, public pool, public skating rink, or other public
- 43 recreational facility.
- 45 of the City of Boston, the board of selectmen, traffic commission, or traffic director, in the
- 46 manner set forth by municipal charter or other local law, in the manner set forth by municipal
- 47 charter or other local law, for the adoption of traffic rules, regulations, ordinances, or bylaws.

- 58 Edition, is hereby amended by inserting after subsection 5, in line 15, the following words:-
- 59 \Box , or (6) within a recreational safety zone which may be established by a city or town as
- 60 provided in section 21B of chapter 85 at a rate of speed exceeding 20 miles per hour or such
- 61 lower speed limit as is set for school zones.
- 62 SECTION 8. Section 2 of chapter 85 of the general laws, as appearing in the 2008 official

- 63 edition, is hereby amended by inserting after the phrase "senior citizen safety zones," the phrase
- 64 "recreational safety zones."
- 65 SECTION 9. Section 16A of Chapter 90 of the General Laws, as appearing in the 2008 Official
- 66 Edition, is hereby amended by striking the words "in excess of five minutes" and inserting in
- 67 place thereof the following "in excess of three minutes".
- 68 SECTION 10. The following words and phrases as used in this section shall have the following
- 69 meanings:-
- 70 "particulate matter" shall mean a broad class of chemically and physically diverse substances
- 71 that exist as discrete particles in air
- 72 "fine particulate matter" shall mean particulate matter less than or equal to 2.5 micrometers in
- 73 diameter
- 74 "ultrafine particulate matter" shall mean particulate matter less than or equal to .1 micrometers
- 75 in diameter (.1 micrometers is equivalent to 100 nanometers)
- 76 SECTION 11. The center for environmental health of the department of public health shall
- 77 conduct a comprehensive study of data on the health effects of particulate air pollution from
- 78 surface transportation. The study shall focus on understanding the health impacts from fine and
- 79 ultrafine particulate matter upon populations that are located within 500 feet of any roadway with
- 80 50,000 or more motor vehicle trips per day, or any rail line regularly used by diesel locomotives;
- 81 provided further, that the study shall include, but not be limited to, examining respiratory and
- 82 cardiovascular disease and cancer incidence that may be affected by exposure to surface
- 83 transportation-related particles. The following departments and agencies of the commonwealth
- 84 shall provide information to the center for environmental health of the department of public
- 85 health relevant to this study: the department of environmental protection, the department of
- 86 transportation (MassDOT), and the central transportation planning staff of the Boston
- 87 metropolitan planning organization. The department of public health shall report its findings, or a
- 88 progress report, together with any recommended response actions by the commonwealth to the
- 89 house and senate committees on ways and means, to the Secretary of the Executive Office of
- 90 Energy and Environmental Affairs, and to the Secretary of the Executive Office of
- 91 Transportation, not later than two years after the adoption of this act; provided further that no
- 92 less than \$250,000 shall be appropriated for this purpose.
- 93 SECTION 12. Chapter 21A of the General Laws is hereby amended by inserting after section
- 94 18A the following section:
- 95 Section 18B: The department of environmental protection in consultation with the department
- 96 of public health shall promulgate regulations, based on the best available science, establishing
- 97 health risk assessment guidelines and exposure standards within the commonwealth for ultrafine
- 98 and fine particulate matter. To ensure the accuracy and completeness of the assessment, the
- 99 department's guidelines shall set forth standard procedures for conducting air dispersion
- modeling; obtaining dose-response values; estimating the frequency, duration, and intensity of
- 101 exposure; and estimating both acute and chronic health risks. Exposure standards shall be based
- 102 on the best available science. The Department of Environmental Protection will develop a plan

- 103 for monitoring particulates so as to acquire data indicative of areas of greatest hazard to human
- 104 health.
- 105 □SECTION 13. Section 9 of Chapter 155 of the Acts of 2010 is hereby amended by striking the
- 106 first sentence and inserting in place thereof the following:-
- 107 ",Section 13B. (a) No operator of a motor vehicle shall use a mobile telephone, as defined in
- 108 Section 3, while operating a motor vehicle on any public way."
