(2021-2022)**

An Act requiring executive agency liability.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1: Definitions

2 (a) Attorney General: The Attorney General of the Commonwealth of Massachusetts

3 (b) Department of Environmental Protection: The Department of Environmental

4 Protection as authorized and created under Chapter 21A of the General Laws of the

5 Commonwealth of Massachusetts

6 (c) Department of Public Utilities: The Department of Public Utilities and authorized and

7 created under Chapter 25 of the General Laws of the Commonwealth of Massachusetts

8 (d) Wanton and reckless behavior: when a person is aware of and consciously disregards
9 a substantial and unjustifiable risk that their acts, or omissions where there is a duty to act, would
10 result in serious bodily injury or substantial risk to residents of the Commonwealth of
11 Massachusetts

12 (e) License: Any license or permit issued by an Agency of the Commonwealth of
13 Massachusetts

14 (f) Natural Gas Compressor Station: Any facility that compresses or directly assists with
15 the compression or transportation of natural gas

16 (g) Natural Gas Pipeline: Any pipes that transport, or directly assist with the compression
17 or transportation of natural gas

18 (h) Official act: Any decision or action in a particular matter of processing a license or
19 permit application.

20 (i) Official responsibility: The direct administrative or operating authority, whether
21 intermediate or final, and either exercisable alone or with others, and whether personal or
22 through subordinates, to approve, disapprove or otherwise direct agency action.

23 (j) Participate: Participate in agency action or in a particular matter personally and
24 substantially as a state, employee, through approval, disapproval, decision, recommendation, the
25 rendering of advice, investigation or otherwise.

26 (k) Public Emergency: Any event involving a natural gas pipeline or natural gas
27 compressor station which causes substantial harm to people of the Commonwealth of
28 Massachusetts including but not limited to explosions, fires, evacuation of communities,

29 substantial harm to property, substantial public health impacts, or otherwise has impacts that
30 significantly disrupt the lives of people and businesses in the Commonwealth of Massachusetts

31 (l) Public Employee: A person performing services for or holding an office, position,
32 employment, or membership in a state agency, whether by election, appointment, contract of hire
33 or engagement, whether serving with or without compensation, on a full, regular, part-time,
34 intermittent, or consultant basis.

35 SECTION 2: If the construction of a natural gas pipeline or natural gas compressor
36 station results in a public emergency, and the construction of the natural gas pipeline or natural
37 gas compressor station required a license, permit, or other official act as a result of the official
38 responsibility of the Department of Environmental Protection or Department of Public Utilities,
39 the Attorney General of the Commonwealth of Massachusetts shall convene an investigation into
40 the licensing and permitting process and any official actions taken by the Department of
41 Environmental Protection or Department of Public Utilities. The Attorney General shall
42 determine if, during the course of this process, the Department(s) had official responsibility
43 regarding the official act to issue permits or licenses and willfully ignored significant risk to the
44 public safety, the public health, and the wellbeing of the people of the Commonwealth of
45 Massachusetts when performing an official act to issue a license for a natural gas pipeline or
46 natural gas compressor station.

47 If it is found that the Department of Environmental Protection or Department of Public
48 Utilities and public employees under their purview engaged in negligent or wanton and reckless
49 behavior, any public employee which had official responsibility regarding the official act to issue
50 permits or licenses shall be civilly liable and subject to damages.

51 For the purposes of this section, wanton or reckless behavior shall be based on an
52 employee's participation in official actions taken through the Department of Environmental
53 Protection or Department of Public Utilities as a result of their official responsibilities to make a
54 determination on permits or licenses for natural gas pipelines or natural gas compressor stations
55 and the judgement shall be made absent consideration of federal laws as justification for issuing
56 licenses and permits.

57 Any public employee which had official responsibility regarding the official act to issue
58 permits or licenses of a natural gas compressor station who is found to have acted negligently in
59 the issuance of said permits or licenses shall be subject to damages under Chapter 229 of the
60 General Laws of the Commonwealth of Massachusetts.
