By Mr. Scaccia of Boston, a petition (accompanied by bill, House, No. 3371) of Angelo M. Scaccia and Jean Ricardo Sillery for legislation to authorize the Registrar of Motor Vehicles to issue temporary license plates for use by purchasers of motor vehicles at auctions. Transportation.

The Commonwealth of Massachusetts

An Act relative to temporary license plates.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 90 of the General Laws is hereby amended by striking out section  
2 2D, as appearing in the 2010 Official Edition, and inserting in place thereof the following  
3 section:-

4 2D (a) The registrar is hereby authorized and empowered to design, issue and regulate the  
5 use of temporary registration plates. Such temporary plates may be issued to dealers, upon  
6 application accompanied by the proper fee, as shall be established by the registrar, for use by  
7 purchasers of motor vehicles; said plates shall be valid for not more than 20 days, pending  
8 receipt of registration plates issued under the provisions of section 2. Satisfactory proof shall be  
9 furnished that a certificate, as defined in section 34A, is in effect prior to the issuance of  
10 temporary plates.

11 (b) The registrar shall design, issue, and regulate the use of temporary registration plates  
12 for use by purchasers of motor vehicles at auction. Such plates shall be made available and  
13 issued to any purchaser at auction, upon an application accompanied by the proper fee, as  
14 established by the registrar. The application shall include the name and license number of the  
15 purchaser. Said plates shall be valid for not more than 7 days. A purchaser shall have the ability  
16 to reactivate and transfer said plates to other vehicles purchased by him or her at auction. There  
17 shall be no limit on the number of times a purchaser may reactivate said plates. Upon  
18 reactivation, said plates shall be valid for not more than 7 days. Said plates shall not be  
19 transferrable to another individual or entity.

20 (c) The registrar is hereby empowered to issue and enforce regulations for the  
21 administration of this section.
