An Act to enhance agricultural operations.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 9 of chapter 90 of the General Laws, as appearing in the 2012 Official Edition, is  
2 hereby amended by striking the third sentence and inserting in place thereof the following 3  
3 sentences:-

4 A tractor, trailer, truck or all-terrain vehicle may be operated without such registration  
5 upon any way for a distance not exceeding one-half mile, if said tractor, trailer, truck or all-  
6 terrain vehicle is used exclusively for agricultural purposes consistent with MGL Chapter 128  
7 Section 1a , or between one-half mile and 10 miles if said tractor, trailer, truck or all-terrain  
8 vehicle is used exclusively for such agricultural purposes and the owner thereof maintains in full  
9 force a policy of liability insurance which conforms to the provisions of section one hundred and  
10 thirteen A of chapter one hundred and seventy-five or for a distance not exceeding three hundred

11 yards, if such tractor, trailer or truck is used for industrial purposes other than agricultural  
12 purposes, for the purpose of going from property owned or occupied by the owner of such  
13 tractor, trailer or truck to other property so owned or occupied.

14 For the purposes of this section, an all-terrain vehicle shall include those vehicles known  
15 as a quad, quad bike, three-wheeler, four-wheeler, or quadricycle as defined by the American  
16 National Standards Institute. Persons utilizing all-terrain vehicles under these provisions shall  
17 annually notify the police department in the municipalities in which they are to operate of the  
18 public way and sections of public way on which they operate in the course of agricultural  
19 purposes. Failure to provide such notification may result in penalties pursuant to MGL Chapter  
20 90, Section 20.

21 All-terrain vehicles operating under the provisions of this section shall be equipped with  
22 a safety flag of not less than 36 square inches in area which shall be elevated to no less than 6  
23 feet from the ground. All-Terrain vehicles must be equipped with a flashing red light mounted to  
24 the rear of the vehicle. If designed to travel at 25 mph or less, the vehicle shall display a “slow  
25 moving vehicle emblem” per MGL Chapter 90 Section 7.

26 Vehicles traveling on a public way subject to this section, shall be operated by a licensed  
27 driver. No all-terrain vehicle may operate on a public way between sunset and sunrise.

28 No all-terrain vehicle may be operated on a public way for recreational or other purposes  
29 except as authorized in this section and MGL Chapter 90B, Sec 25-crossing road at designated  
30 points.
