## AN ACT TO PROTECT NURSING HOME RESIDENTS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 111 of the General Laws, as appearing in the 2006 Official  
2 Edition, is hereby amended by inserting after section 72Z the following section:-

3           Section 72AA. The department, in consultation with the secretary of elder affairs, shall  
4 promulgate further regulations to promote and protect the interests and well being of residents in  
5 nursing homes, rest homes, and long-term care facilities, including but not limited to timely  
6 notification to the resident and designated family member or legal representative of relevant  
7 changes in resident care, posting of care and communication standards in a clear and  
8 conspicuous manner, and process for distributing a copy of all applicable rules and regulations to  
9 the resident, designated family member or legal representative including a written  
10 acknowledgment of receipt.
