Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 7 of chapter 4 of the General Laws, as appearing in the 2012
- 2 Official Edition, is hereby amended by inserting the following definitions under the forty third
- 3 definition:-
- 4 Gold Star Parent, any parent of a member of the armed forces whose death occurred as a
- 5 result of injury sustained, illness, or disease contracted, not due to gross negligence or
- 6 misconduct of the member, during active service.
- Gold Star Spouse, any spouse of a member of the armed forces whose death occurred as a
- 8 result of injury sustained, illness, or disease contracted, not due to gross negligence or
- 9 misconduct of the member, during active service.
