By Representative Mariano of Quincy and Senator Keenan, a joint petition (subject to Joint Rule 12) of Ronald Mariano and John F. Keenan for legislation to authorize the Massachusetts Water Resources Authority to convey a certain parcel of land in the city of Quincy. State Administration and Regulatory Oversight.

The Commonwealth of Massachusetts

An Act authorizing the Massachusetts Water Resources Authority to dispose of real property located in the city of Quincy and to grant an access easement upon real property of the Massachusetts Water Resources Authority located in the city of Quincy.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Pursuant to subsection (d) of section 9 of chapter 372 of the acts of 1984

- 2 and notwithstanding any other general or special law, ordinance or rule or regulation to the
- 3 contrary, the Massachusetts Water Resources Authority is hereby authorized to convey to March
- 4 Fourth, LLC, a limited liability company, a certain parcel of land owned by the Massachusetts
- 5 Water Resources Authority in the City of Quincy consisting of 18,207 square feet as further
- 6 described in Section 4 hereof subject to a permanent easement to be retained by the
- 7 Massachusetts Water Resources Authority for existing pneumatic lines along the north side of a
- 8 building currently located on the parcel of land to be conveyed, for the uninterrupted use of the
- 9 pneumatic lines and the right to maintain, repair or replace the pneumatic lines and other related
- 10 appurtenances.
- SECTION 2. Pursuant to subsection (d) of section 9 of chapter 372 of the acts of 1984
- 12 and notwithstanding any other general or special law, ordinance or rule or regulation to the
- 13 contrary, the Massachusetts Water Resources Authority, may grant a non-exclusive access
- 14 easement to March Fourth, LLC upon a certain parcel of land owned by the Massachusetts Water
- 15 Resources Authority in the City of Quincy consisting of 882 square feet as further described in
- 16 Section 5 hereof.
- SECTION 3. The consideration for the conveyance and grant of easement is the
- 18 conveyance of a permanent right and easement by March Fourth, LLC upon a certain parcel of
- 19 land in the City of Quincy consisting of 11,508 square feet owned by March Fourth, LLC to the
- 20 Massachusetts Water Resources Authority for the Massachusetts Water Resources Authority
- 21 and/or Fore River Railroad Corporation (a Massachusetts corporation being wholly owned by

- 22 Massachusetts Water Resources Authority) to use the parcel as a railroad right of way, including
- 23 the right to operate locomotives and trains across the parcel and to construct, maintain, repair or
- 24 replace railroad bed and track and other appurtenances related to the operation of a railroad and
- 25 maintenance of the railroad right of way over the parcel. The parcel generally located off South
- 26 Street, is more particularly shown as Easement "A" on a plan entitled "Plan of Land, South
- 27 Street in Quincy Massachusetts (Norfolk County) Fore River Shipyard," dated April 11, 2013
- and prepared by BSC Group, Inc. to be recorded with the easement of said parcel.
- 29 SECTION 4. The conveyance to March Fourth, LLC of a certain parcel of land owned by
- 30 the Massachusetts Water Resources Authority referenced in Section 1 and situated on the
- 31 southerly side of South Street in the City of Quincy, County of Norfolk, Commonwealth of
- 32 Massachusetts is more particularly bounded and described as follows:
