An Act to establish a multi-agency task force to combat illegal tobacco sales.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 3. Chapter 12 of the General Laws is hereby amended by adding the followingsection:-

12 Section 33. (a) The General Court finds and declares that:

13	(1) lost revenue from illegal tobacco distribution is estimated at between \$62 million and
14	\$246 million after the most recent tobacco excise tax increases. A reduction of even 10 per cent
15	would mean revenue protection and enhancement of between \$6.2 million and \$24.6 million;
16	(2) the cost to fund a 20-person team to enforce the current law protecting the
17	commonwealth against illegal tobacco distribution is only \$2 million;
18	(3) the creation of joint task forces have proven to be an effective mechanism for
19	combating the illegal tobacco market and enhancing interagency relationships, information
20	sharing, and the prosecution of violators; and
21	(4) a separate trust fund with revenue from the seizure and forfeiture of illegal tobacco
22	product will defray the costs to the commonwealth of investigations and providing additional
23	technical equipment or expertise.

33 (e) The attorney general in conjunction with the state police, the department of revenue 34 and the task force shall enforce criminal violations of chapter 64C which shall include, but not be limited to: (1) investigating and prosecuting allegations of criminal activity related to the 35 possession, sale, delivery or transport of unstamped cigarettes or tobacco products or the 36 37 unauthorized use of tax stamps in the commonwealth; and (2) the seizure and forfeiture of 38 vending machines, receptacles, boxes or cartons in which tobacco products are contained, any vehicle used in the illegal transportation and any records relating to the importation, purchase 39 and sale of unstamped tobacco products. The attorney general shall provide assistance, upon 40 41 request, to the task force in the consideration and promulgation of rules and regulations and shall ensure that there shall be no duplication of duties and responsibilities between the department of 42 43 revenue and the task force.

SECTION 4. Chapter 29 of the General Laws is hereby amended by inserting after
section 2QQQQ, inserted by section 14 of chapter 359 of the acts of 2014, the following section:-

46 Section 2RRRR. (a) There shall be established and set upon the books of the commonwealth a separate fund to be known as the Tobacco Enforcement Trust Fund into which 47 shall be deposited amounts credited or transferred to the fund by the general court or any other 48 source including, without limitation, proceeds from the disposition of forfeited property pursuant 49 to section 38B of chapter 64C, federal grants and any other amounts required to be credited to 50 51 the fund by operation of law. The fund shall be administered by the state treasurer and receiver 52 general. Monies deposited into the fund that are unexpended at the end of the fiscal year shall not revert to the General Fund and shall be available for expenditure in the subsequent fiscal year. 53

54 (b) Amounts credited to the fund shall be used, without further appropriation, to provide 55 funding to the interagency task force on illegal tobacco enforcement established by section 33 of 56 chapter 12 for the enforcement of chapter 64C.

57 SECTION 5. Chapter 64C of the General Laws is hereby amendment by inserting after 58 section 38A the following section:-

59 Section 38B. When a court proceeding under this chapter results in a final order of forfeiture pursuant to this chapter, the final order shall provide for disposition of forfeited items 60 61 in any manner not prohibited by law, including official use by an authorized law enforcement or other public agency, including members of the interagency task force on illegal tobacco 62 enforcement, or sale at public auction or by competitive bidding; and deposit of the monies and 63 64 proceeds of any such sale, less associated expenses, to the Tobacco Enforcement Trust Fund, from which the funds may be expended by members of the said task force for tobacco 65 enforcement-related purposes, including defraying the costs of investigations and providing 66 additional technical equipment or expertise. 67
