Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Said section 31 of said chapter 94C, as so appearing, is hereby further

14	Regulations Part 1308.15, unless specifically excepted or unless listed in another class in this
15	section.
16	SECTION 4. Said section 31 of said chapter 94C, as so appearing, is hereby further
17	amended by inserting after "CLASS E" the following:-
18	Notwithstanding any special or general law to the contrary, under no circumstances shall
19	the classification of marijuana be linked to the federal scheduling system as determined by Title
20	21 of the Code of Federal Regulations Part 1308.11.
