Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 47G of chapter 175 of the General Laws, as appearing in the 2008 Official
- 2 Edition, is hereby amended by adding the following sentence:-- Annual cytologic screenings
- 3 performed at the same time as an annual physical exam may be separately billed by the health
- 4 care provider and shall be paid by the insurer.
- 5 SECTION 2. Subdivision L of section 110 of said chapter 175, as so appearing, is hereby
