An Act exempting Martin B. Parayno from the maximum age requirement for firefighters in the city of Methuen.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 1. Notwithstanding sections 58, 61A and 61B of Chapter 31 of the General Laws  
2 or any General or Special law to the contrary, Martin B. Parayno may have his name certified for  
3 original appointment to the position of firefighter in the City of Methuen, notwithstanding having  
4 reached the age of 32 before taking any civil service examination in connection with such  
5 appointment. In all other respects, Martin B. Parayno shall be eligible for appointment to the  
6 position of fire fighter in the City of Methuen only insofar as he qualifies and is selected for  
7 employment under Chapter 31 of the General Laws, any regulations of the Civil Service  
8 Commission and any lawful hiring practices of the City of Methuen. This exemption shall apply  
9 only to the certified lists assembled under the examination conducted prior to the adoption of this  
10 act.

11           Section 2. This act shall take effect upon its passage.
