**In the One Hundred and Ninetieth General Court  
(2017-2018)**

An Act prohibiting the collection of personal information from a consumer.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 93 of the General Laws, as appearing in the 2014 Official Edition,  
2 is hereby amended by inserting after section 114 the following section:-

3 Section 115. No telecommunications or internet service provider that has entered into a  
4 franchise agreement, right-of-way agreement, or other contract with the state of Massachusetts or  
5 a political subdivision, or that uses facilities that are subject to such agreements, even if it is not a  
6 party to the agreement, may collect personal information from a customer resulting from the  
7 customer’s use of the telecommunications or internet service provider without express written  
8 approval from the customer.

9 SECTION 2. This act shall take effective upon its passage.
