By Representative Reinstein of Revere and Senator Petruccelli, a joint petition (accompanied by bill, House, No. 3783) of Kathi-Anne Reinstein and Anthony W. Petruccelli (with the approval of the mayor and city council) for legislation to authorize the conveyance of certain parcels of land in the city of Revere. State Administration and Regulatory Oversight. [Local Approval Received.]

AN ACT AUTHORZING THE CONVEYANCE OF CERTAIN PARCELS OF LAND IN THE CITY OF REVERE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1. The City of Revere, acting by and through its Mayor and City Council, in concurrence with the approval granted by the Conservation Commission of the City of Revere, may convey to 2 the Commonwealth, acting by and through the commissioner of conservation and recreation, for 3 4 conservation purposes, 89.21 acres of City of Revere real property, located in the Rumney Marsh Area of Critical Environmental Concern identified on the City of Revere Zoning Atlas Map, on 5 6 file in the office of the City Clerk of the City of Revere, as follows: Map 19, block 327, Parcels 7 3, 4, 5, 6, 8, 10, 11, 13, 14, 15 and 16 containing 40.36 acres. Map 19, Block 328, Parcels 2, 3 and 6 containing 14.34 acres. Map 19, Block 329, Parcel 10 containing 1.3 acres. Map 20, Block 8 9 329, Parcels 1, 13, and 14 containing 15.25 acres. Map 20, Block 330, Parcels 3 and 4 containing 10 14.50 acres, and Map 30, Block 448A, Parcel 2 containing 3.46 acres.

Section 2. The parcels of land described in Section 1 of this Act may be conveyed by the City of 11 Revere to the Commonwealth, acting by and through the commissioner of conservation and 12 recreation, subject to the following conditions. Consideration for said parcels shall be the fair 13 market value of the parcels as determined by an agreement between the City of Revere and 14 department of conservation and recreation dated March 15, 2001, as amended and on file with 15 16 the department. The deed conveying the parcels of land described in Section 1 of this Act shall contain a restriction prohibiting any building on such property and precluding any use of the said 17 parcels other than for passive recreation purposes. The commissioner of conservation and 18 19 recreation shall include the parcels of land described in Section 1 of this Act in its Rumney Marsh Reservation managed by the department of conservation and recreation and shall protect 20and preserve such land as park land in accordance with Article 97 of the Articles to the 21 22 Constitution of the Commonwealth of Massachusetts.

Section 3. The City Solicitor and/or the Assistant City Solicitor of the City of Revere, at the
City's expense, shall prepare the necessary documents to convey the aforementioned City of
Revere real property described in Section 1 to the Commonwealth, acting by and through the
commissioner of conservation and recreation.

Section 4. Pursuant to the express authority in Chapter 841 of the Acts of 1975, and in conjunction with the transit-oriented development at Revere Beach, as described in a draft and final environmental impact report approved by the secretary of energy and environmental affairs, the Commonwealth, acting by and through the commissioner of the division of capital asset management and maintenance in consultation with the commissioner of conservation and recreation, may convey to the City of Revere certain parcels known as the "north lot" and the "maintenance facility lot" subject to the provisions of Section 5 of this Act and in connection with said conveyance the division of capital asset management and maintenance is hereby authorized to take by eminent domain all or any portions of said parcels (including any former street locations adjacent thereto) to confirm the Commonwealth's title thereto. The north lot is currently used as a public parking area and the maintenance facility lot is currently used as a public parking area and for department of conservation and recreation maintenance activities.

Section 4A. Pursuant to authority in Chapter 841 of the Acts of 1975 and in furtherance of the 39 intent of Chapter 877 of the Acts of 1977, the Commonwealth, acting by through the 40 commissioner of the division of capital asset management and maintenance in consultation with 41 the commissioner of conservation and recreation shall convey to the MBTA for nominal 42 consideration that certain parcel of land located within the limits of Chester Avenue in Revere. 43 Massachusetts, adjacent to Parcel "A" as described in Chapter 77 of the Acts of 1977 and shown 44 as Parcel "X" on that certain plan entitled "Plan of Land, Wonderland Station, Ocean Avenue, 45 Revere, Massachusetts," prepared by Nitsch Engineering and dated July 8, 2008. 46

47 Section 5. The parcels of land described in Section 4 of this Act may be conveyed by the Commonwealth, acting by and through the commissioner of the division of capital asset 48 management and maintenance in consultation with the commissioner of conservation and 49 recreation, to the City of Revere, subject to the following conditions. The City shall only transfer 50 the maintenance facility lot, or portion thereof, to a redeveloper, as provided under Chapter 841 51 52 of the Acts of 1975, upon completion and delivery of a replacement maintenance facility to the Commonwealth which is acceptable to the department of conservation and recreation. In 53 conjunction with the conveyance of the maintenance facility lot to the City, the City shall grant a 54 55 lease to the Commonwealth for nominal consideration for such portion of the maintenance facility lot as shall be necessary to allow the department of conservation and recreation's 56

continued use of the maintenance facility located on the maintenance facility lot, which use shall 57 terminate upon the transfer of a replacement maintenance facility to the department. In addition, 58 the City of Revere shall grant a lease to the Commonwealth for nominal consideration for such 59 portion of the north lot as shall be necessary to accommodate the department of conservation and 60 recreation's beach management and maintenance activities on a temporary basis during the 61 62 construction of the pedestrian bridge described in Section 7 of this Act and the construction of the beach operations facility described in Section 8 of this Act, which use shall commence upon 63 the commencement of construction of the beach operations facility as described in Section 8 of 64 65 this Act and shall terminate upon the completion of construction of the beach operations facility and the transfer of a replacement maintenance facility to the department. Consideration to be 66 paid by the City to the Commonwealth for the north lot and for the maintenance facility lot shall 67 68 be the fair market value of the parcels, as determined by the agreement between the City of Revere and the department of conservation and recreation dated March 15, 2001, as amended 69 70 and on file with the department. Upon the sale by the City of Revere of the north lot, the maintenance lot, or any portion of either lot, the city shall deposit the proceeds from such sale 71 into an escrow account established by the commissioner of the division of capital asset 72 73 management and maintenance, in consultation with the commissioner of conservation and 74 recreation, and the city of Revere, and said deposited funds, together with any interest earned thereon, shall be used for the construction of a replacement maintenance facility for the 75 76 department of conservation and recreation on the Revere beach reservation, provided, however, that the design and construction of the replacement maintenance facility shall be subject to the 77 78 review and approval by the division of capital asset management and maintenance and the department of conservation and recreation; provided further that the disbursement of funds from 79

the escrow account shall be subject to the approval of the division of capital asset management 80 and maintenance and the department of conservation and recreation, on such terms and 81 conditions as may be set forth in any agreement governing the escrow account; provided further 82 that such escrow agreement shall, without limitation, provide that if the city of Revere does not 83 complete the construction of the replacement maintenance facility by such date as may be 84 85 specified in the escrow agreement, the division of capital asset management and maintenance, in consultation with the department of conservation and recreation, may use the funds in the escrow 86 account for the design and construction of the replacement maintenance facility, provided that 87 88 any funds paid into the escrow account from the sale of the north lot, the facility maintenance lot, or portions thereof which are not needed for the design and construction of the replacement 89 maintenance facility shall be paid to the commonwealth in accordance with the escrow 90 agreement, and contain such other provisions as the commissioner of the division of capital asset 91 management and maintenance, in consultation with the department of conservation and 92 recreation, deem appropriate. 93

94 Section 6. The commissioner of the division of capital asset management and maintenance, 95 acting in consultation with the commissioner of conservation and recreation, shall prepare the 96 necessary documents to convey the aforementioned real property described in Section 4 to the 97 City of Revere. The City of Revere shall be responsible for all costs, including, without 98 limitation, recording fees, to effect the transactions contemplated by Sections 4 and 5 of this act. 99 Section 7. In conjunction with the transit-oriented development described in Section 4 of this 100 Act, the City of Revere and/or the Massachusetts Bay Transportation Authority or their

101 respective agents are hereby authorized to construct a pedestrian bridge over Ocean Avenue in

102 the City of Revere and to place the footings of said bridge in the Revere Beach Reservation, a

property owned by the Commonwealth and used for recreation and other public purposes. The pedestrian bridge shall be owned by the Commonwealth and maintained by the City of Revere or its' assignee and shall serve as a connection between the Revere Beach Reservation and nearby transit facilities.

107 Section 8. In conjunction with the transit-oriented development and the pedestrian bridge 108 described in Section 7 of this Act, in accordance with a plan on file with the department of 109 conservation and recreation, a beach operations facility may be constructed by the City of Revere 110 or its designee pursuant to an open solicitation process on land owned by the Commonwealth 111 within the Revere Beach Reservation.

Section 9. In recognition of the federal and municipal open, public procurement procedures that 112 113 have been or will be applied to all aspects of the design and construction of the parking garage, the public plaza, the pedestrian bridge and the beach operations facility, the provisions of 114 Massachusetts General Laws chapter 7, chapter, 30B and chapter 149, sections 44A through 115 44M, shall not apply to the design or construction of the public plaza or other public amenities 116 that may be constructed in connection with the transit-oriented development described in Section 117 4 of this Act, the pedestrian bridge described in Section 7 of this Act and the beach operations 118 facility described in Section 8 of this Act 119

Section 10. The following roadways within or proximate to the transit-oriented development and the Revere Beach Project area as defined by Chapter 841 of the Acts of 1975, and as more specifically described in a map on file with the City of Revere, are hereby designated by the Commonwealth as Scenic Byways: Revere Beach Parkway, Winthrop Parkway-Winthrop Shore

- 124 Drive, Revere Beach Boulevard, Ocean Avenue, Chester Street, Chester Avenue, West Street,
- 125 part of Revere Street, part of Beach Street and part of Shirley Avenue.
- 126 Section 11. This act shall take effect upon its passage.
