An Act protecting the religious freedom of students.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

- 1 Chapter 71 is hereby amended by inserting after Section 1B the following section:-
- 2 Section 1C. Notwithstanding any special or general law to the contrary, school districts
- 3 beginning with the 2013-2014 school year, shall adopt and implement a local policy that allows
- 4 for a limited public forum and voluntary student expression of religious viewpoints at school
- 5 events and graduation ceremonies, in class assignments, and in non-curricular school groups and
- 6 activities. Districts shall treat such expression on an otherwise permissible subject in the same
- 7 manner as the expression of a secular or other viewpoint and prohibits the district from
- 8 discriminating against a student based on his or her expressed religious viewpoint. The policy
- 9 must require the district to ensure that a student speaker does not engage in obscene or indecent
- 10 speech and to provide a disclaimer that a student's speech is not endorsed or sponsored by the
- 11 district.
