An Act authorizing the town of Milford to grant 1 additional license for the sale of wines and malt beverages to be drunk on the premises.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws, the  
2           licensing authority of the town of Milford may grant 1 additional license for the sale of wines  
3           and malt beverages to be drunk on the premises pursuant to section 12 of said chapter 138 to  
4           Canvas n Cup, LLC., located at 189 Main street in the town of Milford. The license shall be  
5           subject to all of said chapter 138 except said section 17.

6           (b) Notwithstanding any general or special law to the contrary, the licensing authority  
7           shall not approve the transfer of the license to any other location but it may grant the license to a  
8           new applicant at the same location if the applicant files with the licensing authority a letter from  
9           the department of revenue and a letter from the department of unemployment assistance  
10          indicating that the license is in good standing with those departments and that all applicable  
11          taxes, fees and contributions have been paid.

12 (c) If the license granted pursuant to this act is cancelled, revoked or no longer in use at  
13 the location of original issuance, it shall be returned physically, with all of the legal rights,  
14 privileges and restrictions pertaining thereto, to the licensing authority, which may then grant the  
15 license to a new applicant at the same location and under the same conditions as specified in this  
16 act.

17 SECTION 2. This act shall take effect upon its passage.
