## The Commonwealth of Massachusetts

In the Year Two Thousand Fourteen

An Act authorizing the lease of air rights over a portion of a municipal off-street parking area - rear of the property located at 280-290 Harvard Street.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding any general or special law to the contrary, the town of

- 2 Brookline may lease any part or portion of the air rights over a certain parcel, currently or
- 3 hereafter owned by the town, to Hamilton Charitable Corporation, duly organized under the laws
- 4 of the commonwealth with its usual place of business being 39 Brighton avenue in the city of
- 5 Boston, or its designee, so that the Coolidge Corner Theatre Foundation may expand its
- 6 operations as a community movie house within property owned by Hamilton Charitable
- 7 Corporation located at 280-290 Harvard street in the town of Brookline. The board of selectmen
- 8 shall determine the terms and conditions of the lease in the best interests of the town; provided,
- 9 however, that the period of the lease shall not exceed 99 years. The parcel, which is used as an
- 10 off-street parking area and located on the northeasterly side of Centre street to the rear of the
- 11 property located at 280-290 Harvard street in the town of Brookline, is generally known, referred
- 12 to and shown as Parcel 14 in Block 082 on Sheet 16 of the town's 2013 Assessors Atlas and
- 13 depicted, in part, on a "Site Plan of Coolige Corner Theater in Brookline, Mass.", dated
- 14 February 20, 2013 by Neponset Valley Survey Assoc., Inc. The air rights to be leased over the
- 15 parcel contains approximately 950 square feet as shown on said plan as "proposed air easement"
- 16 and is bounded and described as follows:
- Beginning at a point on the southerly property line of the Coolidge Corner Theatre, said
- 18 point being 37.10' feet northwesterly from the southerly property corner of said theatre, thence
- 19 running:
- Southwesterly by land now or formerly of the town of Brookline, 10.00'; thence running
- 21 northwesterly by land now or formerly of the town of Brookline 95.00'; thence running

- 22 northeasterly by land now of the town of Brookline 10.00'; thence running along the southerly
- 23 property line 95.00 to the point of beginning.
- Said air rights are above an area that is 950 square feet more or less.
- Said air rights are as shown on a plan entitled "Site Plan at Coolige Corner Theatre in
- 26 Brookline, Mass." as prepared by Neponset Valley Survey associates, Inc. and dated February
- 27 20, 2013.
- SECTION 2. This act shall take effect upon its passage.
