**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act relative to a cranberry wetland mitigation bank.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1. (a) Notwithstanding any general or special law to the contrary,
2 the executive office of energy and environmental affairs shall establish a cranberry wetlands
3 mitigation banking pilot program. The purpose of the program is to provide off-site mitigation
4 for public and private projects to comply with orders of conditions or variances issued in
5 accordance with the Wetlands Protection Act under section 40 of chapter 131 of the General
6 Laws and related regulations under 310 CMR 10.00.

7 The off-site mitigation of wetlands under the program shall be located on approved
8 cranberry bog lands considered in agricultural use under said regulations.

9 (b) All project sites that require mitigation and bog lands used for off-site mitigation
10 under the program shall be located in the South Coastal, Taunton, or Buzzards Bay regional
11 watersheds that lie within the respective counties of Bristol and Plymouth.

12 (c) The use of bog land for off-site mitigation shall require the approval of the
13 executive office of energy and environmental affairs. Such approved bog land may include the

14 100 foot wide buffer zone land area around the bog; provided, the use of buffer zone land for off-
15 site mitigation shall exclude any part of the area: (i) not owned by the bog landowner, (ii) within
16 a 100 feet of another bog of the landowner that is in agricultural use under said regulations and
17 not approved or proposed for off-site mitigation, or (iii) necessary for current and future uses,
18 including access roads and other improvements.

19 Bog land used for off-site mitigation may also include any increase of the bog area
20 under a predetermined plan to renovate and expand the existing wetland.

21 No approval shall take effect, unless the bog landowner and the secretary of energy
22 and environmental affairs confirm by written agreement to the use of the specific bog land for
23 off-site mitigation, allowable bank credits, and any other terms and conditions required by this
24 section or by a rule adopted under the subsection (g).

25 (d) For approval of bog land for off-site mitigation, the landowner shall be required to
26 grant a permanent conservation restriction or easement of such land to a qualified government
27 entity or non-profit organization that commonly holds conservation restrictions in the
28 commonwealth. Any restriction granted by a landowner shall be conditional, to take effect upon
29 the first use or trade of one or more bank credits from the mitigation bank for such bog land. The
30 terms of the restriction or easement shall be subject to approval by the secretary of energy and
31 environmental affairs; provided however, such terms shall include a prohibition on the
32 agricultural use of the land. The terms of the conservation restriction or easement shall be part of
33 the agreement between the landowner and secretary under the prior subsection.

34 A landowner may grant a conservation restriction or easement to a qualified
35 government entity or non-profit organization that acts as a bank agent for the mitigation bank for
36 the owner's bog land, or approves the land for off-site mitigation.

37 (e) The establishment of a mitigation site shall also be subject to the approval of the
38 local conservation commission having jurisdiction.

39 (f) Bank credits from a mitigation bank shall be available only in exceptional
40 circumstances and after full consideration of all regulatory requirements to avoid, minimize and
41 mitigate a public or private project's impacts on-site, to the fullest extent, are not practicable or
42 less beneficial environmentally as determined by the local conservation commission having
43 jurisdiction of the project. A local conservation commission may send a project to a mitigation
44 bank that meets the requirements of the program, provided the landowner of the project consents
45 in writing.

46 (g) Within 150 days after the effective date of this act, the executive office of energy
47 and environmental affairs shall adopt written rules for the administration and procedures of the
48 program, to include without limitation, uniform policies for the approval of bog lands as
49 mitigation sites, the method to determine the value of bank credits, and the qualifications and
50 requirements of banker agents of mitigation banks. As necessary, the executive office of energy
51 and environmental affairs may upon 60 days advance public notice, amend or repeal such rules.
52 The adoption, amendment or repeal of program rules shall not be subject to the provisions of
53 section 2 through 9, inclusive, of chapter 30A of the General Laws. Such rules in effect shall
54 comply with any applicable federal laws and regulations for wetland banking. The executive
55 office of energy and environmental affairs shall post on its public website all program rules.

56 For the purposes limited to the program, the executive office of energy and
57 environmental affairs may establish rules that (i) preempt municipal wetland protection by-laws
58 or ordinances, and (ii) waive the requirement that bog mitigation sites be approved by local
59 conservation commissions, notwithstanding the provisions of subsection (e).

60 (h) There shall be established an advisory committee to make recommendations to the
61 executive office of energy and environmental affairs on establishing uniform administrative
62 procedures, rules and policies for the program. The committee's recommendations shall include,
63 without limitation, advice on policies related to the approval of off-site mitigation bog lands,
64 operation and administration of mitigation banks, and bank credit valuations of land. The
65 committee shall consist of the following 7 members: the secretary of energy and environmental
66 affairs, or his designee, who shall serve as chairman; the commissioner of the department of
67 agricultural resources, or his designee; the commissioner of the department of environmental
68 protection, or his designee; the commissioner the department of fish and game, or his designee;
69 and 3 members to be appointed by the secretary of energy and environmental affairs, 1 of whom
70 shall be a member of a municipal conservation commission; 1 of whom shall be a representative
71 of an association of cranberry growers in the commonwealth, and 1 of whom shall be a cranberry
72 grower with bog lands in Bristol or Plymouth county. The appointment of committee members
73 shall be for the term of the advisory committee. Any person appointed to fill a vacancy on the
74 committee shall be appointed in a like manner; and shall serve for only the unexpired term of the
75 member who vacated. Appointments to the committee shall be made within 60 days after the
76 effective date of this act. The term of the advisory committee shall expire 2 years from the
77 effective date of this act.

78 (i) Within 30 days after the adoption of the rules as provided in subsection (f), the
79 executive office of energy and environmental affairs shall issue a request for proposals for the
80 selection of a contractor with knowledge of state and federal wetland protection laws and
81 regulations, cranberry agriculture and said regional watersheds, to serve as the initial bank agent
82 of a combined bog land mitigation bank and to assist with the administration and monitoring of
83 the program. The term of the initial bank agent shall be for a period of not less than 1 year.

84 Within 90 days of issuing the request for proposals, the executive office of energy and
85 environmental affairs shall select the initial bank agent. The request for proposals and selection
86 of the initial bank agent shall not be subject to the provisions of chapter 30B of the General
87 Laws.

88 The executive office of energy and environmental affairs and the initial bank agent,
89 shall develop an agreement for the use and transfer of bank credits from the combined bank. The
90 agreement shall be subject to the review and approval of the inspector general.

91 Compensation for the services of the initial bank agent may be paid from
92 administrative fees collected from landowners of bog mitigation sites and project users of the
93 mitigation bank.

94 (j) Notwithstanding the provisions of the prior subsection, a bog landowner may only
95 after the first year of the initial bank agent's term, utilize any qualified non-profit organization,
96 or private entity or person to establish a separate mitigation bank and act as bank agent for such
97 owner's approved bog lands.

98 (k) The executive office of environmental affairs no later than March 1 of each year,
99 shall file an annual report that provides an assessment of the program for the prior calendar year,

100 with the senate and house chairpersons of the joint committee on environment, natural resources
101 and agriculture. Each report shall contain information about bog lands accepted for off-site
102 mitigation including information on the amount, acreage, location and types of wetlands restored
103 and credits issued or traded, and list of all projects utilizing bog site bank credits, and the
104 environmental effectiveness of mitigation banks in protecting wetland resources under the
105 program. A report shall be filed for each year the program is in existence.

106 (l) For the purposes of this section the term “Bank Credits” or “Credits”, shall mean
107 the 1 or more units of trade that quantifies and represents the environmental value of the
108 mitigation bog land, as determined by acreage, location, natural resource purpose and natural
109 habitat value, or other uniform method of assessment, as established under program rules.

110 SECTION 2. Subsections (a) through (l), inclusive, of section 1 shall be repealed 5
111 years from the effective date of this act; except, subsection (k) of said section 1 shall be repealed
112 on March 1 next occurring from the date said other subsections are repealed.
