### The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act relative to the classification of certain controlled substances.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- Paragraph (a) of Class B of section 31 of chapter 94C of the General Laws is hereby
- 2 amended by striking out clause (4), as appearing in the 2014 Official Edition, and inserting in
- 3 place thereof the following clause:-
- 4 (4) Coca leaves, except coca leaves and extracts of coca leaves from which cocaine,
- 5 ecgonine, and derivatives of ecgonine or their salts have been removed; Cocaine, its salts, optical
- 6 and geometric isomers, and salts of isomers; Ecgonine, its derivatives, their salts, isomers, and
- 7 salts of isomers; or any compound, mixture, or preparation which contains any quantity of any of
- 8 the substances referred to in this clause.
