An Act relative to Division of Professional Licensure demographics reporting.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 13, as appearing in the 2018 Official Edition, is hereby amended  
2 by inserting after Section 109 the following new section: -

3 Section 110. The division of professional licensure shall collect and publish on an annual  
4 basis the demographic data of applicants for initial licensure and renewal of licensure in  
5 professions that provide mental health and addiction treatment. At a minimum, the division of  
6 professional licensure shall report data from the following boards of registration:

- 7 (a) Board of registration in social work;
- 8 (b) Board of registration in the allied mental health and human services professions; and
- 9 (c) Board of registration of psychologists.

10 The boards of registration shall collect the following information for each applicant:

- 11 (a) Race;
- 12 (b) Ethnicity;
- 13 (c) Language (primary and secondary);
- 14 (d) Gender;
- 15 (e) Gender Expression;
- 16 (f) County(ies) where applicant intends to practice or currently practices;
- 17 (g) School where master's degree was conferred;
- 18 (h) Years of prior experience in the field of behavioral health;
- 19 (i) Jurisdictions where currently or previously licensed;
- 20 (j) Application decision;
- 21 a. If application resulted in denial, the division shall report reason(s) for denial;
- 22 (k) Speed of application decision.

23 The division of professional licensure shall publish this data in aggregate form no later  
24 than 90 days after the close of the fiscal year. Published data shall be available in searchable,  
25 sortable format to allow for the cross-tabulation of statistical variables.

26 The division of professional licensure shall complete all obligations under this section  
27 within six months of enactment of this section.
