An Act relative to parenting time rights.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. As used in this chapter the following words, unless the context requires
2 otherwise, shall have the following meanings:—

3 “parenting time” refers to a period of time that a parent spend with his or her child
4 pursuant to a court order under this chapter.
