Howitt relative to roadway damage caused by certain motor vehicle accidents; the petition (accompanied by bill, House, No. 3501) of Steven S. Howitt and Timothy R. Whelan relative to roadway littering; the petition (accompanied by bill, House, No. 3543) of Christina A. Minicucci and Marcos A. Devers relative to the definition of autocycles; the petition (accompanied by bill, House, No. 3546) of Lenny Mirra for legislation relative to the use of road flaggers and police details on public works projects; the petition (accompanied by bill, House, No. 3562) of Jerald A.
