Ayers relative to the lease of property used by non-profit yacht clubs and other non-profit organizations operating boating programs; the petition (accompanied by bill, House, No. 787) of Colleen M. Garry relative to communities being granted Brownsfields Assessment and Remediation Funds, notwithstanding the participation of the regional planning organization; the petition (accompanied by bill, House, No. 847) of Smitty Pignatelli relative to establishing the snowmobile trail maintenance fund for the grooming, maintaining, and repairing of certain publicly-owned trails; the petition (accompanied by bill, House, No. 864) of Angelo M. Scaccia and David Hodgdon that the Department of Conservation and Recreation be directed to build a public access around Hollingsworth Dam in the Neponset River in the town of Milton; the petition (accompanied by bill, House, No. 866) of Angelo M. 1           *Ordered,* That the committee on Environment, Natural Resources and Agriculture be  
2 authorized to sit during a recess of the General Court to make an investigation and study of  
3 House documents numbered 741, 742, 787, 847, 864, 866, 867, 872 and 881, relative to  
4 Department of Conservation and Recreation fees, funds and property and a cranberry water use  
5 transfer program.

6           Said committee shall report to the General Court the results of its investigation and study  
7 and its recommendations, if any, together with drafts of legislation necessary to carry such  
8 recommendations into effect, by filing the same with the Clerk of the House of Representatives  
9 on or before December 31, 2020.
