By Mr. Madden of Nantucket and Senator Wolf, a joint petition (accompanied by bill, House, No. 567) of Timothy R. Madden and Daniel Wolf (by vote of the town) relative to establishing a separate cemetery commission for the town of Nantucket. House Steering, Policy and Scheduling. [Local Approval Received.]

The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act establishing a separate cemetery commission for the town of Nantucket.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. For the purposes of this act, the words and phrases set forth in this section shall
2 have the following meanings:
- 3 The Board of Cemetery Commissioners of the Town of Nantucket shall consist of five persons
4 appointed by the Board of Selectmen. Two Commissioners shall be appointed for three years,
5 one Commissioner shall be appointed for two years and two Commissioners shall be appointed
6 for one year. Thereafter, the terms shall be appointed for three years.

- 8 The Cemetery Commission shall meet from time to time and no less than annually, and
9 organize by the choice of its members a Chairman, a Vice Chairman and a Secretary. It shall be
10 the duty of the Secretary to keep a record of the doings, receipts and expenditures of the
11 Cemetery Commission and render a specific report to be filed with the Town Clerk and the

12 Board of Selectmen on or about July 15, to be printed in the Annual Town Report.

14 SECTION 2. Duties of the Cemetery Commission.

16 A. The Cemetery Commission shall have full charge of all of the public cemeteries of the
17 Town, to lay out the same into lots, to execute and deliver deeds therefore, and to erect all
18 necessary signs, fences, buildings and other structures in or about the same, at an expense not to
19 exceed, in any case, the amount of the funds at its disposal.

20 B. The Cemetery Commission shall direct the expenditures of all general cemetery funds in
21 the cemetery account and of all specific appropriations, unless otherwise ordered by the Town,
22 and the income of all trust funds held by the Town for cemetery purposes, conforming to the
23 directions of the depositor.

24 C. The Cemetery Commission shall keep a complete record of all sales of lots in the public
25 cemeteries of the Town and the deeds thereof, together with the names of the deceased and the
26 location of the graves. True copies of all such deeds, names, and grave locations shall be on file
27 with the Town Clerk.

29 SECTION 3. Authority to make rules and regulations.

30 The Cemetery Commissioners, with the approval of the Board of Selectmen, are hereby
31 authorized and empowered to make changes to cemetery rules and regulations not contrary to
32 law with regard to the use of the Town cemeteries, and said rules and regulations shall be on file
33 with the Town Clerk.

34 SECTION 4. This act, being necessary for the welfare of the town and county of Nantucket

35 and its inhabitants, shall be liberally construed to effect its purposes.

36 SECTION 5. This act shall become effective on the date passed by the Legislature, or

37 approved by the Governor.
