#### The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An act to establish a subcommittee of dental hygienists within the board of registration in dentistry.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 AN ACT TO ESTABLISH A SUBCOMMITTEE OF DENTAL HYGIENISTS WITHIN THE
- 2 BOARD OF REGISTRATION IN DENTISTRY.
- 3 Be it enacted by the Senate and House of Representatives in General Court assembled, and by
- 4 the authority of the same, as follows:
- 5 SECTION 1. Section 19 of chapter 13 of the General laws, as amended by section 1 and section
- 6 2 of chapter 530 of the acts of 2008, is hereby amended by adding the following three paragraphs
- 7 There shall be a sub-committee of dental hygienists, referred to in the following sections as
- 8 "the subcommittee", added to the board of registration in dentistry in the following sections
- 9 called the "board", consisting of 7 persons, each of whom shall be a legal resident of the
- 10 commonwealth, 1 of whom shall be a dental hygienist who is a member of the board; 4 of whom

- shall be a graduate of a reputable school of dental hygiene and a reputable dental hygienist who
- 12 has maintained a license to practice dental hygiene in the commonwealth for the 5 years
- 13 preceding his appointment by the governor; 1 of whom shall be a representative of the public,
- 14 subject to the provisions of section 9b; and 1 of whom shall be a dentist on the board, appointed
- 15 by the president of the board. The governor shall appoint annually in April a successor to those
- 16 members of the subcommittee whose terms are expiring in that month. Each of the 2 members of
- 17 subcommittee who also are members of the board shall serve on the subcommittee for the
- 18 duration of that member's term on the board. The term of a member of the subcommittee who is
- 19 not a member of the board is 3 years. No member shall serve more than 2 full terms. The
- 20 subcommittee shall elect officers annually as deemed necessary to administer its duties and as
- 21 provided in rules and regulations. The dental hygienist who is serving on the board shall chair
- 22 the subcommittee. The subcommittee shall meet at the call of the chair, at least twice a
- 23 year. Members of the subcommittee are entitled to compensation and expenses as provided in
- 24 MGL Chapter 13 Sections 19-21. The subcommittee may provide by rule for compensation to
- 25 subcommittee members for the performance of official duties at a rate that is greater than the rate
- 26 provided in MGL Chapter 13 Sections 19-21.
- 27 SECTION 2. The subcommittee shall have the authority to adopt recommendations regarding the
- 28 practice, regulation, discipline, education, examination, and licensure of dental hygienists,
- 29 subject to section 3, and shall carry out duties as assigned by the board. The subcommittee shall
- 30 have no regulatory or disciplinary authority with regard to dentists, dental assistants, dental lab
- 31 technicians, or any other auxiliary dental personnel. A simple majority of the subcommittee
- 32 members currently serving shall constitute a quorum.

SECTION 3. The board shall ratify recommendations of the subcommittee at the first meeting of the board following adoption of the recommendations by the subcommittee, or at a meeting of 34 the board specifically called for the purpose of board review and ratification of subcommittee recommendations. The board shall decline to ratify subcommittee recommendations only if the 36 37 board makes a specific finding that a recommendation exceeds the jurisdiction or expands the 38 scope of the committee beyond the authority granted in section 2, creates an undue financial impact on the board, or is not supported by the record. The board shall pay the necessary 39 expenses of the subcommittee and of the board in implementing subcommittee recommendations 40 ratified by the board. 41
