Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 2 Section 121 of chapter one hundred forty of the general laws is hereby amended by deleting in
- 3 line 20 the following:

- 4 "(i) any of the weapons, or replicas or duplicates of such weapons, specified in appendix A to 18
- 5 U.S.C. section 922 as appearing in such appendix on September 13, 1994, as such weapons were
- 6 manufactured on October 1, 1993; (ii) any weapon that is operated by manual bolt, pump, lever
- 7 or slide action;".

- 8 SECTION 2 Subsection (a) of section 131 of chapter one hundred forty of the general laws is
- 9 hereby amended by inserting after the word "firearms" in line 6 the following: "other than
- 10 assault weapons".
- 11 SECTION 3 Subsection (a) of section 131 of chapter one hundred forty of the general laws is
- 12 hereby amended by inserting after the word "weapons" in line 9 the following: "other than
- 13 assault weapons".
- 14 SECTION 4 Subsection (a) of section 131 of chapter one hundred forty of the general laws is
- 15 hereby amended by deleting in line 48 the following: "(v) hunting in accordance with the
- 16 provisions of chapter 131".
- 17 SECTION 5 Subsection (a)(6) of section 10 of chapter two hundred sixty-nine of the general
- 18 laws is hereby amended by deleting in line 29 the following: "not less than two and one-half
- 19 years nor more than five years, or for not less than one year nor more than two and one-half
- 20 years in a jail or house of correction" and inserting in place thereof the following:
- 21 "not less than three years".
