An Act prohibiting discrimination in sober housing..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 140 of the General Laws, as appearing in the 2000 Official Edition, is
- 2 hereby amended by striking out section 22 and inserting in place thereof the following section:
- 3 Section 22. "Lodging house", as used in sections twenty-two to thirty-one, inclusive,
- 4 shall mean a house where lodgings are let to four or more persons not within the second degree
- 5 of kindred to the person conducting it, and shall include fraternity houses and dormitories of
- 6 educational institutions, but shall not include dormitories of charitable or philanthropic
- 7 institutions or convalescent or nursing homes licensed, or group residences licensed or regulated
- 8 by agencies of the commonwealth under section seventy-one of chapter one hundred and eleven
- 9 or rest homes so licensed, or homes occupied by recovering alcoholics or drug addicts, who are

- 10 deemed handicapped pursuant to 42 U.S.C. § 3602, and who are living together as a single
- 11 housekeeping unit.
- 12 SECTION 2. Chapter 148 of the General Laws, as appearing in the 2000 Official Edition, is
- 13 hereby amended by deleting the second paragraph of section 26H and inserting in place thereof
- 14 the following paragraph:
- 15 For the purpose of this section "lodging house" or "boarding house" shall mean a house where
- 16 lodgings are let to six or more persons not within the second degree of kindred to the person
- 17 conducting it, but shall not include fraternity houses or dormitories, rest homes or group
- 18 residences licensed or regulated by agencies of the commonwealth, or homes occupied by
- 19 recovering alcoholics or drug addicts, who are deemed handicapped pursuant to 42 U.S.C.
- 20 § 3602, and who are living together as a single housekeeping unit.
