AN ACT RELATIVE TO VOTING BY THE INSTANT RUNOFF VOTING METHOD IN PRIMARIES..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority
of the same, as follows:*

1 SECTION 1. Section 2 of chapter 50 of the General Laws as appearing in the 2002 Official
2 Edition is hereby amended by striking out the third sentence and inserting in place thereof the
3 following:—

4 This section shall not apply to nominations and elections by ballot at primaries or caucuses. The
5 Instant Runoff Voting method, as defined in section 1 of chapter 50 shall be the method used for all
6 primary elections and caucuses for the following offices when three or more candidates have qualified to
7 have their names printed on the ballot: governor, lieutenant governor, attorney general, secretary of the
8 commonwealth, state treasurer, state auditor, and representative and senator in general court. Ballots shall
9 allow the voter to mark the voter's first choice in the same manner as that for offices not elected by
10 Instant Runoff Voting. Sample ballots illustrating voting procedures shall be posted in or near the voting
11 booth, and shall be included in the instruction packet for absentee ballots. Directions to voters shall
12 conform substantially to the following:

13 “Vote for your first-choice candidate by marking the number ‘1’ next to that candidate’s name. In
14 addition to your first choice candidate, you may rank additional candidates in order of
15 preference. Ranking additional candidates will not affect your first-choice candidate. Indicate your
16 second choice by marking the number ‘2’ by that candidate’s name, your third choice by marking the
17 number ‘3,’ and so on for as many candidates as you wish. Do not mark the same number beside more
18 than one candidate. Do not skip numbers.”

19 The secretary of the commonwealth shall adopt and promulgate regulations consistent with this
20 section, which regulations shall ensure that ballots shall be simple and easy to understand. As soon as
21 practicable, the secretary of the commonwealth shall ensure that all voting equipment in the
22 commonwealth is capable of effecting Instant Runoff Voting. In addition, the secretary of the
23 commonwealth shall conduct a voter education campaign to familiarize voters with Instant Runoff
24 Voting.

25 SECTION 2. Section 1 of chapter 50 of the General Laws as appearing in the 2002 Official Edition is
26 hereby amended by inserting after the definition of “federal act” the following definition:—

27 “Instant Runoff Voting” means a method of casting and tabulating votes that simulates the ballot counts
28 that would occur if all voters participated in a series of runoff elections with one candidate eliminated
29 after each round of counting. In elections using the Instant Runoff Voting method, voters may rank the
30 candidates in order of preference. In all such elections, the count shall proceed in the following manner:

31(1) The initial round of counting shall be a count of the first choices marked on each ballot. If any candidate
32 receives a majority of the first choices, that candidate shall be deemed and declared elected.

33(2) If no candidate receives a majority of first choices, there shall be a second round of counting. The last-
34 place candidate shall be eliminated, and all the continuing ballots shall be recounted. “Continuing ballot”
35 means a ballot that is not an exhausted ballot.

36(3) Each continuing ballot shall be counted as one vote for that ballot's highest ranked advancing
37 candidate. "Advancing candidate" means a candidate who has not been eliminated.

38(4) If no candidate receives a majority at the second round of counting, there shall be a third round of
39 counting. The last-place candidate shall be eliminated, and all the continuing ballots shall be
40 recounted. Each continuing ballot shall be counted as one vote for that ballot's highest ranked advancing
41 candidate.

42(5) The process of eliminating the last-place candidates and recounting all the continuing ballots shall
43 continue until one candidate receives a majority of the votes in a round. The candidate who receives a
44 majority of the votes in a round shall be deemed and declared to be elected.

45(6) When a ballot becomes an exhausted ballot it shall not be counted in that round or any subsequent
46 round. "Exhausted ballot" means a ballot on which there are no choices marked other than choices for
47 eliminated candidates.

48(7) If there are not sufficient second and lower choices for any candidate to receive a majority, the candidate
49 with the highest number of votes shall be deemed and declared to be elected.

50(8) No candidate who has been eliminated can be elected, no matter how many second and lower ranked
51 choices might otherwise have become votes for that candidate in a later round.
