An Act relative to swimming pool alarms

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 140 of the General Laws is hereby amended by adding the
- 2 following section:-
- 3 Section 207. As used in this section, the following words shall, unless the context clearly
- 4 appears otherwise, have the following meanings:-
- 5 "Pool alarm", a device which meets and is independently certified to the ASTM Standard F 2208
- 6 "Standards Specification for Pool Alarms" which includes surface motion, pressure, sonar, laser,
- 7 and infrared type alarms. Pool alarms shall not include swimming protection alarm devices

- 8 designed for individual use, such as an alarm attached to a child that sounds when the child
- 9 exceeds a certain distance or becomes submerged in water.
- 10 "Swimming pool", any structure that contains water over 24 inches in depth and which is used,
- 11 or intended to be used, for swimming or recreational bathing located indoors or outdoors and
- 12 which is available only to the family and guests of a residential household, including in-ground,
- 13 above-ground and on-ground swimming pools, hot tubs and spas.
- 14 No building permit shall be issued for the construction or substantial alteration of a swimming
- 15 pool at a residence occupied by, or being built for, 1 or more families unless a pool alarm is
- 16 installed with the private swimming pool.
- 17 No swimming pool shall be used for swimming or recreational bathing unless a pool alarm is
- 18 installed with the swimming pool by the owner of the residence. Every swimming pool shall be
- 19 inspected annually by the inspector of buildings of each city and town in which said pool is
- 20 located for the presence of an operating pool alarm.
- 21 Each owner or tenant of every residence required to have a pool alarm in accordance with this
- 22 section who fails to comply with this section regarding pool alarms shall be fined not less than
- 23 \$100 nor more than \$500 for each offense.
