An Act relative to food assistance for senior citizens.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. The department of transitional assistance shall promulgate regulations that,  
2 to the extent allowable under federal law, simplify the recertification process for persons who are  
3 65 or older and applying for recertification of benefits under the supplemental nutrition  
4 assistance program. The regulations shall, to the extent allowable under federal law, limit and  
5 reduce the documentation relating to household income and expenses that is required to be  
6 submitted for persons who are 65 or older and applying for recertification of benefits under the  
7 supplemental nutrition assistance program. The department may apply for waivers from the  
8 Federal Food and Nutrition Service within the United States Department of Agriculture pursuant  
9 to 7 C.F.R. s. 272.3(c) to carry out this section if, in the opinion of the commissioner of  
10 transitional assistance, the waiver would result in a more effective and efficient administration of  
11 the supplemental nutrition assistance program for persons who are 65 or older.

12 SECTION 2. (a) The department of transitional assistance shall apply for a waiver from  
13 the Federal Food and Nutrition Service within the United States Department of Agriculture  
14 pursuant to 7 C.F.R. s. 272.3(c) allowing the commonwealth to promulgate regulations to  
15 prohibit a decrease in benefits provided to a person who is 65 or older under the supplemental  
16 nutrition assistance program upon eviction or loss of housing by that person.

17 Upon approval of a waiver by the Federal Food and Nutrition Service pursuant to this  
18 subsection, the department of transitional assistance shall promulgate regulations prohibiting a  
19 decrease in benefits provided to a person who is 65 or older under the supplemental nutrition  
20 assistance program upon eviction or loss of housing by that person.

21 (b) The department of transitional assistance shall apply for a waiver from the Federal  
22 Food and Nutrition Service within the United States Department of Agriculture pursuant to 7  
23 C.F.R. s. 272.3(c) allowing the commonwealth to promulgate regulations to prevent a  
24 disproportionate decrease in benefits provided to a person who is 65 or older under the  
25 supplemental nutrition assistance program after an increase in income by that person or that  
26 person's household.

27 Upon approval of a waiver by the Federal Food and Nutrition Service pursuant to this  
28 subsection, the department of transitional assistance shall promulgate regulations to prevent a  
29 disproportionate decrease in benefits provided to a person who is 65 or older under the  
30 supplemental nutrition assistance program after an increase in income by that person or that  
31 person's household.
