An Act authorizing the Massachusetts Water Resources Authority to release easements upon certain real property in the town of Stoneham.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Notwithstanding any general or special law to the contrary, but subject to
- 2 subsection (d) of section 9 of chapter 372 of the acts of 1984, the Massachusetts Water
- 3 Resources Authority is hereby authorized to release or relocate three easements upon a certain
- 4 parcel of land in the Town of Stoneham owned or formerly owned by Langwood Commons,
- 5 LLC as described in section 2.
- 6 Section 2. The three easements that may be released or relocated by the Massachusetts
- 7 Water Resources Authority in section 1 upon a certain parcel of land located in the Town of
- 8 Stoneham owned or formerly owned by Langwood Commons, LLC are more particularly shown
- 9 as "water Easement (WE-1)", "AE-8", and "Proposed 25' Utility Easement" on Lot L on a plan
- recorded as Plan No. 1364 of 2007 in the Middlesex South Registry of Deeds.

| 11 | Section 3. In consideration for the release or relocation of the three easements by the |
