In the Year Two Thousand Eleven

An Act authorizing the Division of Capital Asset Management and Maintenance to convey a certain parcel of land in the town of Danvers located along Maple Street..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. The commissioner of capital asset management and maintenance may, subject to
- 2 the provision of Section 40E to 40J, inclusive, of Chapter 7 of the General Laws, convey by a
- 3 deed a certain undeveloped parcel of state-owned land which is a part of a larger parcel owned
- 4 by the Commonwealth and under the use and control of the Massachusetts State Police,
- 5 commonly referred to as the Troop A Headquarters, in Danvers, Massachusetts. The property to
- 6 be conveyed hereunder, is generally described as follows: a parcel of land along Maple Street,
- 7 beginning at the point where the state-owned land intersects with property owned by the parcel
- 8 owned by the Hathorne Office Park Condominium and continuing clockwise along a boundary

- 9 of land owned by the Putnam Cemetery, to a driveway located on the state-owned parcel and
- 10 then continuing clockwise along the driveway to Maple Street, and then along Maple Street to
- 11 the point of beginning. The exact boundaries of the parcel shall be determined by the
- 12 commissioner, in consultation with the secretary of public safety and the Massachusetts State
- 13 Police, after completion of a survey.
- 14 SECTION 2. The consideration to be paid for said property shall be the full and fair market
- 15 value of the property, as determined by the commissioner of capital asset management and
- 16 maintenance based upon an independent appraisal. The inspector general shall review and
- 17 approve the appraisal and the review shall include a review of methodology used for the
- 18 appraisal. The inspector general shall prepare a report of his review and file the report with said
- 19 commissioner for submission to the house and senate committees on ways and means and
- 20 chairmen of the joint committee on state administration.
- 21 SECTION 3. The grantee of said property shall be responsible for any costs for appraisals,
- 22 surveys and other expenses relating to the transfer of property.
- 23 SECTION 4. The payment of the consideration for the property, as determined under section 2,
- shall be deposited in the General Fund, provided, however, that as an alternative to depositing
- 25 the consideration in the General Fund, the commissioner, in consultation with the secretary of
- 26 public safety and the Massachusetts State Police, may allow all or a portion of said consideration
- 27 to be used for improvements to the facilities at the Troop A Headquarters or for the purchase of
- 28 equipment used by Troop A.
