By Mr. Welch, a petition (accompanied by resolve, Senate, No. 1230) of James T. Welch, Marcos A. Devers, Jose F. Tosado and Jeffrey Sánchez for legislation to establish an advisory committee on the accessibility of fresh food retail in communities throughout the Commonwealth. Public Health.

## The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

Resolve establishing an advisory committee on the accessibility of fresh food retail in communities throughout the Commonwealth.

1 Resolved, that an advisory committee is hereby established to examine the accessibility 2 of fresh food retail in communities throughout the commonwealth. The advisory committee shall 3 develop criteria to determine which communities lack adequate access to fresh food retail, 4 particularly urban and rural communities; investigate the causes of inadequate access to fresh food retail; study the public health impact of inadequate access to fresh food retail; develop 5 innovative strategies and recommendations to increase access to fresh food retail, including: 6 legislation, economic incentives and financing options, improvements to transportation, public-7 private partnerships, pilot program(s), and the improvement of food programs already in 8 existence. The advisory committee shall calculate the costs and potential savings of all strategies 9 and recommendations and determine the benefits, drawbacks, and feasibility of all strategies and 10 recommendations. 11

12 The advisory committee shall consist of 11 members, 1 of whom shall be the13 commissioner of the department of public health, or a designee, who shall serve as chair of the

advisory committee; 1 of whom shall be the secretary of the executive office of housing and 14 economic development, or a designee; 1 of whom shall be the commissioner of the department of 15 agricultural resources, or a designee; 2 of whom shall be the chairs of the joint committee on 16 public health; 1 of whom shall be a nutritionist appointed by the commissioner of the department 17 of public health; 5 of whom shall be appointed by the governor and shall include: a 18 19 representative of the supermarket industry, a representative of farmers markets, a representative of the gateway cities, a representative of non-for-profit hunger relief organizations, and a 20representative of the Massachusetts Public Health Association. 21

The advisory committee shall commence no later than 90 days after enactment of this section.

The advisory committee shall report all findings, recommendations, and draft legislation to the senate and house committees on ways and means, the chairs of the joint committee on community development and small business, the chairs of the joint committee on public health, and the chairs of the joint committee on children, families, and persons with disabilities no later than 18 months after enactment of this section.

29 The advisory committee shall sunset upon submission of the report to the pertinent30 committees.
