**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act to update postural screenings in schools.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 57 of chapter 71 of the General Laws, as appearing in the 2016 Official Edition,
- 2 is hereby amended by striking out, in line 21, the words “annually in grades five through nine”
- 3 and inserting in place thereof the following words:- “in grades 6, 7, 8, or 9.”
