Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. The eleventh paragraph of section eighty-one of chapter one hundred
- 2 forty-six of the General Laws, as appearing in the 2006 Official Edition, is hereby amended by
- 3 inserting after the words "pumping equipment" the following:-
- 4 , vacuum and pneumatic systems, oil and petroleum products, ice making machinery, air
- 5 conditioning equipment, and piping systems used for the conveyance and storage of liquids and
- 6 industrial type gases used in processes, including, but not limited to, biopharama and semi-
- 7 conductor manufacturing,

- 8 SECTION 2. Section eighty-nine of said chapter one hundred forty-six is hereby
- 9 further amended by inserting at the end thereof the following:
- Whoever prevents or attempts to prevent any inspector from entering on any premises in the discharge of his duty with respect to section eight-one shall be punished by a fine of not less than two hundred and fifty dollars and not more than three thousand dollars, or by
- 14 Any person who permits an unlicensed person to operate engage in pipefitting, as
 15 defined in section eighty-one, shall be subject to a fine of not less than one thousand dollars and

imprisonment for not more than three months, or both such fine and imprisonment.

- 16 not more than three thousand dollars, or by imprisonment for not more than three months, or
- 17 both such fine and imprisonment.
