An Act to improve food allergy awareness.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

- 1 Section Section 6B of Chapter 140 of the General Laws, as appearing in the 2016 Official
- 2 Edition, is hereby amended by inserting, in section (b), the following new subsection:-
  
- 3 (3) designate a server or other individual who is knowledgeable about the relevant issues
- 4 concerning food allergies as they relate to food preparation to coordinate food service and
- 5 preparation for customers with identified food allergies.
