## The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act authorizing the Division of Capital Asset Management and Maintenance to lease or sell the national guard armory in the city of Worcester.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Notwithstanding sections 40E to 40J, inclusive, of chapter 7 of the General
- 2 Laws, the commissioner of capital asset management and maintenance may enter into
- agreements for the lease or sale of the former National Guard Armory in the city of Worcester to
- 4 Veteran's Inc. to accommodate the expansion of services for the needs of current and returning
- 5 services members and their families.
- 6 The parcel was conveyed to the commonwealth by deed dated December 9, 1907 and recorded in the Worcester district registry of deeds in book 1870, page 253 and 254. 7
- 8 The parcels are shown as follows:
