An Act relative to essential health benefits.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1: Section 59 of Chapter 40 of the General Laws, as appearing in the 2012
2 Official Edition, is hereby amended by inserting

3 SECTION 2: Section 31A of Chapter 63 of the General Laws, as appearing in the 2012
4 Official Edition, is hereby amended by inserting the following subsection:-

5 (n) Any corporation that receives a tax credit under this section shall provide to its
6 employees a health insurance plan that includes, at a minimum, all of the essential health benefits
7 required under the Massachusetts essential health benefit benchmark plan.

8 SECTION 3: Section 31C of said Chapter 63, as so appearing, is hereby amended by
9 inserting the following subsection:-

10 (e) Any corporation that receives a tax credit under this section shall provide to its
11 employees a health insurance plan that includes, at a minimum, all of the essential health benefits
12 required under the Massachusetts essential health benefit benchmark plan.

13 SECTION 4: Section 31M of said Chapter 63, as so appearing, is hereby amended by
14 inserting the following subsection:-

15 (g) Any corporation subject to taxes imposed by chapter 63 that receives a tax credit
16 under this section shall provide to its employees a health insurance plan that includes, at a
17 minimum, all of the essential health benefits required under the Massachusetts essential health
18 benefit benchmark plan.

19 SECTION 5: Section 38M of said Chapter 63, as so appearing, is hereby amended by
20 inserting the following subsection:-

21 (k) Any corporation that receives a tax credit under this section shall provide to its
22 employees a health insurance plan that includes, at a minimum, all of the essential health benefits
23 required under the Massachusetts essential health benefit benchmark plan.

24 SECTION 6: Section 38N of said Chapter 63, as so appearing, is hereby amended by
25 inserting the following subsection:-

26 (h) Any corporation that receives a tax credit under this section shall provide to its
27 employees a health insurance plan that includes, at a minimum, all of the essential health benefits
28 required under the Massachusetts benchmark plan.
