**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to medical services.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of chapter 111C of the General Laws, as appearing in the 2016
2 Official Edition, is hereby amended by striking out the definition of Commissioner and inserting
3 in place thereof the following definition:-

4 “Commissioner”, the commissioner of public safety;

5 and by striking out the definition of Department and inserting in place thereof the
6 following definition:-

7 “Department”, the department of public safety.

8 SECTION 2. Section 1 of chapter 111O of the General Laws, as so appearing, is hereby
9 amended by striking out the definition of Commissioner and inserting in place thereof the
10 following definition:-

11 “Commissioner”, the commissioner of public safety;

12 and by striking out the definition of Department and inserting in place thereof the
13 following definition:-

14 “Department”, the department of public safety.
