An Act to promote environmentally sound transportation of agricultural products.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Paragraph 3 of subsection (d) of section 5 of chapter 90 of the General Laws, as  
2 appearing in the 2010 Official Edition, is hereby amended by adding the following sentence:-  
3 Farm vehicles may carry up to the gross vehicle weight rating provided they comply with section  
4 19A.
