By Mr. Brewer, petition (accompanied by bill, Senate, No. 1646) of Cariddi and Brewer for legislation to promote transparency in electric bills [Joint Committee on Telecommunications, Utilities and Energy].

## The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act promoting transparency in electric bills.

*Whereas,* the deferred operation of this act would tend to defeat its purpose, which is forthwith to establish a framework for consumer electricity rate savings and to make certain other changes in law, necessary or appropriate to effectuate important public purposes, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. This Act shall be entitled the "The Ratepayer Protection Act", and shall be
2	construed in a manner to achieve its public purpose, which is to ensure that affordable electric
3	service be available to all consumers on reasonable terms and conditions.

SECTION 2. Notwithstanding any general or special law, rule, or regulation to the
contrary, each calender year, the department of public utilities shall conduct a public hearing to

6 evaluate the economic consequences to the consumers of the costs assessed on residential and commercial ratepayers to meet the renewable portfolio standards of the Commonwealth, 7 including the Commonwealth's expenditures for administration and enforcement of all 8 renewable energy programs, incentives, and funding available in the Commonwealth. The 9 department of public utilities shall develop and issue, by Marsh first of each year, a report which 10 11 shall detail the amount in the previous calendar year of wholesale and retail pricing, that is directly attributable to the Commonwealth's renewable portfolio standard requirements. The 12 department may include in such report recommendations to address any identified pricing 13 mechanism flaws that, if corrected, could result in lower energy cost to ratepayers. The 14 department is hereby authorized and directed to promulgate rules and regulations necessary to 15 carry out the provisions of this section. 16

17 SECTION 3. Notwithstanding any general or special law, rule or regulation to the contrary, beginning January 1, 2012, all electric bills sent to retail and commercial customers by 18 an electric or distribution company or competitive supplier shall include a separate line-item to 19 reflect the rate charged for renewable energy generation, transmission, and distribution services 20 contained in the total retail price. The department is hereby authorized and directed to determine 21 whether any additional information shall be required to be disclosed on the bills and to 22 23 promulgate rules and regulations to implement the provisions of this subsection. Rules and regulations relative to the appeals process for billing disputes or damage claims made by 24 customers shall be published and distributed to customers as part of an education and outreach 25 26 program.
